14. TWO-YEAR EXTENSION OF PERMIT PRC 4371.2 TO PROSPECT FOR GEOTHERMAL RESOURCES, PATENTED SCHOOL LAND NORTHWEST OF THE GEYSERS STEAM FIELD, LAKE COUNTY; HERMAN B. GLEBE, RUBY E. GLEBE, AND RICHARD L. GLEBE - W 9568, PRC 4371.2.

EXTENSION OF A PERMIT TO PROSPECT FOR GEOTHERMAL
RESOURCES PRC 4371.2

PERMITTEE: Herman B. Glebe, Ruby E. Glebe, and Richard L. Glebe.

LOCATION: Five miles northwest of The Geysers Steam Field, Lake County.

ACREAGE: 600 acres more or less.

TYPE OF LAND: Patented school land, reserved mineral interest.

EXPIRATION DATE: November 13, 1972.

PREREQUISITE ITEMS: a. Application submitted by permittee.
b. Statutory filing fee paid.

WORK PERFORMED: During the primary three-year term, the following exploration work has been conducted in the area of the subject permit:

Aero magnetic and gravity survey.

Infra-red surveys.

Geothermal, geological and geochemical studies.

Geo-thermal well logging.

CONSIDERATION: \$600 per annum.

OTHER PERTINENT INFORMATION: Permit to Prospect for Geothermal Resources PRC 4371.2 was issued on November 14, 1969, for the primary three-year term to Herman B. Glebe, Ruby E. Glebe, and Richard L. Glebe. The permittees have requested a two-year extension for further evaluation of the data obtained during the primary term.
