ENVIRONMENTAL IMPACT STATEMENT OF TIDELANDS

The City of Long Beach has prepared an Environmental Impact Statement of tidelands oil development and operations of the Long Beach tidelands, for use in compliance with the State Environmental Quality Act and in applying for permits from the South Coast Regional Coastal Zone Conservation Commission under the California Coastal Zone Conservation Act of 1972.

The summary of oil operations in the Long Beach tidelands shows no adverse impact now occurring or expected in the future from development and operation.

The City of Long Beach will request permits from the South Coast Regional Coastal Zone Conservation Commission (SCRC) for future development projects on Long Beach tidelands. These permits, when approved, will allow the City of Long Beach to continue the development of the tideland oil properties which were granted in trust to the City by the State of California. All development and operations will be conducted pursuant to applicable statutes and in the public interest.

The Division has reviewed this Environmental Impact Statement entitled "Environmental Impact Statement, Long Beach Tidelands and Unit Oil and Gas Operations, Wilmington and East Wilmington Oil Fields" and has found it to be appropriate.

IT IS RECOMMENDED THE COMMISSION USE THE "ENVIRONMENTAL IMPACT STATEMENT, LONG BEACH TIDELANDS AND UNIT OIL AND GAS OPERATIONS, WILMINGTON AND EAST WILMINGTON OIL FIELDS" AS REFERENCE IN APPROVALS CONCERNING FUTURE OIL DEVELOPMENT OF THE LONG BEACH TIDELANDS.
