RATIFICATION OF THE NINTH MODIFICATION OF THE 1972-1973 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach, in accordance with Section 5(g), Chapter 138/1964, 1st E.S., has requested Commission approval of the Ninth Modification of the Plan of Development and Operations and Budget, Long Beach Unit (July 1, 1972 through June 30, 1973).

Pursuant to Section 5(g), Chapter 138/1964, 1st E.S., the Acting Executive Officer, by letter dated February 5, 1973, approved the Ninth Modification of the 1972-1973 Plan and Budget, subject to ratification by the Commission.

This Ninth Modification provides for an additional Budget Item, III.B.4.d., <u>Prior Year Expense Adjustments</u>, in order to permit segregation of prior year production expense adjustments from current year operating costs.

Additionally, this modification provides \$16,000, by transfer, to Budget Item III.A.2.e.(2), Waste Disposal Facilities, to allow for the purchase of sand storage and waste container equipment. This is now being leased by the Unit to maintain environmental standards. The present lease-purchase contract has reached the end of its term, and the purchase option will be exercised in order to take advantage of the Unit's accumulated equity in the equipment.

With the approval of this modification the affected Budget Items will be adjusted as follows:
