

12. DREDGING PERMIT, PORTIONS OF GALLINAS CREEK BETWEEN SAN PABLO BAY AND GALLINAS VILLAGE, MARIN COUNTY; COUNTY OF MARIN, DEPARTMENT OF PUBLIC WORKS - W 20248, PRC 4741.1.

After consideration of Calendar Item 10 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. FINDS THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 92 ON FILE IN THE OFFICES OF THE COMMISSION AND BY REFERENCE MADE A PART HEREOF, ISSUANCE OF THE DREDGING PERMIT AS RECOMMENDED HEREIN WILL NOT RESULT IN A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
2. AUTHORIZES THE ISSUANCE OF A DREDGING PERMIT TO THE COUNTY OF MARIN, DEPARTMENT OF PUBLIC WORKS, TO DREDGE 115,000 CUBIC YARDS OF MATERIAL FROM THREE STATE MINERAL-INTEREST AREAS IN GALLINAS CREEK, MARIN COUNTY, AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITHOUT ROYALTY, ALL SUCH DREDGED MATERIAL TO BE SPOILED ON LANDS WHICH ARE TO BE DEVELOPED INTO THE MARIN COUNTY NORTH BAY FRONT PARK; SAID PERMIT TO BE EFFECTIVE FROM MARCH 29, 1973, TO DECEMBER 31, 1975, CONDITIONAL TO THE ISSUANCE OF PERMISSION FOR THE WORK BY THE ARMY CORPS OF ENGINEERS.

APPLICATION FOR DREDGING PERMIT

APPLICANT: County of Marin, Department of Public Works.

DREDGE AREA: Portions of Gallinas Creek between San Pablo Bay and Gallinas Village, Marin County, granted to Marin County with minerals retained by the State.

LOCATION: Approximately three miles north of San Rafael.

PURPOSE: To restore small craft navigability from San Pablo Bay to community of Gallinas Village.

VOLUME: 115,000 cubic yards.

SPOIL/FILL LOCATION:

All material to be spoiled in vicinity of dredge area on lands owned by County of Marin. Such land to be developed into Marin County North Bay Front Park.

CONSIDERATION: Improvement of navigation for public recreational boating (public use and benefit).

OTHER PERTINENT DATA:

1. Pursuant to the requirements of Section 6371 of the Public Resources Code, an environmental impact report has been prepared concluding that the proposed project will not have a significant detrimental environmental effect. Copies of the report, EIR No. 92, have been filed in the offices of the Commission in Long Beach and Sacramento and are available to the public.
2. A permit for the project has been issued by the San Francisco Bay Conservation and Development Commission.
3. A Certificate of Conformance has been issued by the State Water Resources Control Board.
4. Issuance of a State dredging permit to be conditional on issuance of Department of Army, Corps of Engineers permit.
5. The proposed dredge area was previously dredged in 1966 under Dredging Permit PRC 3483.1, effective April 28, 1966, to December 31, 1969. The creek has silted up

since the 1966 dredging, and it is calculated that a total of 115,000 C.Y. will have to be removed to regain the original dredge depth.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 92 ON FILE IN THE OFFICES OF THE COMMISSION AND BY REFERENCE MADE A PART HEREOF, ISSUANCE OF THE DREDGING PERMIT AS RECOMMENDED HEREIN WILL NOT RESULT IN A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
