10. ASSIGNMENT FROM KIMBERLY-CLARK CORPORATION TO SIMPSON LEE PAPER COMPANY OF LEASE PRC 3051.1, SUBMERGED LAND IN THE SACRAMENTO RIVER NEAR ANDERSON, SHASTA COUNTY - W 20427, PRC 3051.1.

THE COMMISSION AUTHORIZES THE APPROVAL OF AN ASSIGNMENT OF LEASE PRC 3051.1 COVERING A PARCEL OF SUBMERGED LAND IN THE SACRAMENTO RIVER NEAR ANDERSON, SHASTA COUNTY, FROM KIMBERLY-CLARK CORPORATION TO SIMPSON LEE PAPER COMPANY.

ASSIGNMENT OF LEASE PRC 3051.1

ASSIGNOR: Kimberly-Clark Corporation.

ASSIGNEE: Simpson Lee Paper Company.

LOCATION: A 2.04-acre parcel of submerged land in the Sacramento River near Anderson, Shasta County.

LAND USE: An existing effluent outfall line.

TERMS OF ORIGINAL LEASE:

Initial period: 15 years, from August 29, 1963.

Renewal options: Three additional periods of ten years each.

CONSIDERATION: \$150 per annum.

STATUTORY AND OTHER REFERENCES:

a. Public Resources Code: Division 6, Parts 1 and 2.

b. Administrative Code: Title 2, Division 3, Articles 1 and 2.

OTHER PERTINENT INFORMATION:

1. Kimberly-Clark Corporation transferred the upland, together with improvements thereon, by Grant Deed to Simpson Lee Paper Company. An executed assignment has accordingly been received with request for Commission approval.

2. This transaction is not a change in the basic purpose of the lease; therefore, no environmental impact report is required pursuant to an opinion of the Attorney General dated December 10, 1970.
