## QUITCLAIM OF MINERAL LEASE

LEASE: Mineral Extraction Lease PRC 1850.1, issued January 15, 1958, for 20 years to January 15, 1978.

LESSEE: Ideal Basic Industries, Inc.

LEASE LAND: Approximately 4,730 acres of sovereign State tide and submerged land located in the middle of South San Francisco Bay immediately north of the San Mateo Bridge.

AUTHORIZED OPERATIONS:

Dredging and removal of shell deposits for use in lessee's cement manufacturing operations.

LESSEE'S REASON TO QUITCLAIM: Lease material no longer needed by lessee due to closing of lessee's cement plants at Redwood City and San Juan Batista.

## OTHER PERTINENT DATA:

- Lessee has submitted the required Lease Quitclaim Deed forms correctly executed for the requested quitclaim. Original request was filed on November 24, 1970, requesting quitclaim to be effective on January 15, 1971.
