

8. 49-YEAR PUBLIC AGENCY PERMIT, TIDE AND SUBMERGED LAND IN THE PACIFIC OCEAN AT LIMEKILN CREEK, MONTEREY COUNTY; DEPARTMENT OF TRANSPORTATION, DIVISION OF HIGHWAYS - W 20264, PRC 4800.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. FINDS THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 117 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, A PUBLIC AGENCY PERMIT AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
2. AUTHORIZES THE ISSUANCE TO THE DEPARTMENT OF TRANSPORTATION, DIVISION OF HIGHWAYS, OF A 49-YEAR PUBLIC AGENCY PERMIT FROM AUGUST 1, 1973; AND THE EXECUTION OF A PLAT PURSUANT TO STREETS AND HIGHWAYS CODE SECTION 101.5; IN CONSIDERATION OF THE MONETARY VALUE OF THE RIGHT-OF-WAY TO BE DEPOSITED IN THE GENERAL FUND FOR CREDIT TO THE RESOURCES PROTECTION ACCOUNT; FOR THE CONSTRUCTION AND MAINTENANCE OF HIGHWAY AND BANK STABILIZATION MEASURES ON THE LAND DEPICTED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY PERMIT

APPLICANT: Department of Transportation, Division of Highways.
LOCATION: A 0.29-acre parcel of tide and submerged land in the Pacific Ocean at Limekiln Creek, Monterey County.
LAND USE: Construction and maintenance of highway and bank stabilization measures.

TERMS OF PROPOSED LEASE:
Initial period: 49 years, from August 1, 1973.

CONSIDERATION: A monetary value of the right-of-way to be determined pursuant to Streets and Highways Code Section 101.5.

PREREQUISITE TERMS:
Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:
a. Public Resources Code: Div. 6, Parts 1 and 2.
b. Administrative Code: Title 2, Div. 3, Arts. 1 and 2.
c. Streets and Highways Code: Section 101.5.

OTHER PERTINENT INFORMATION:
1. The annual rental value of the site is estimated to be \$100.
2. The project is to correct erosion of the support for the highway by the sea. No additional vehicle capacity is being provided.

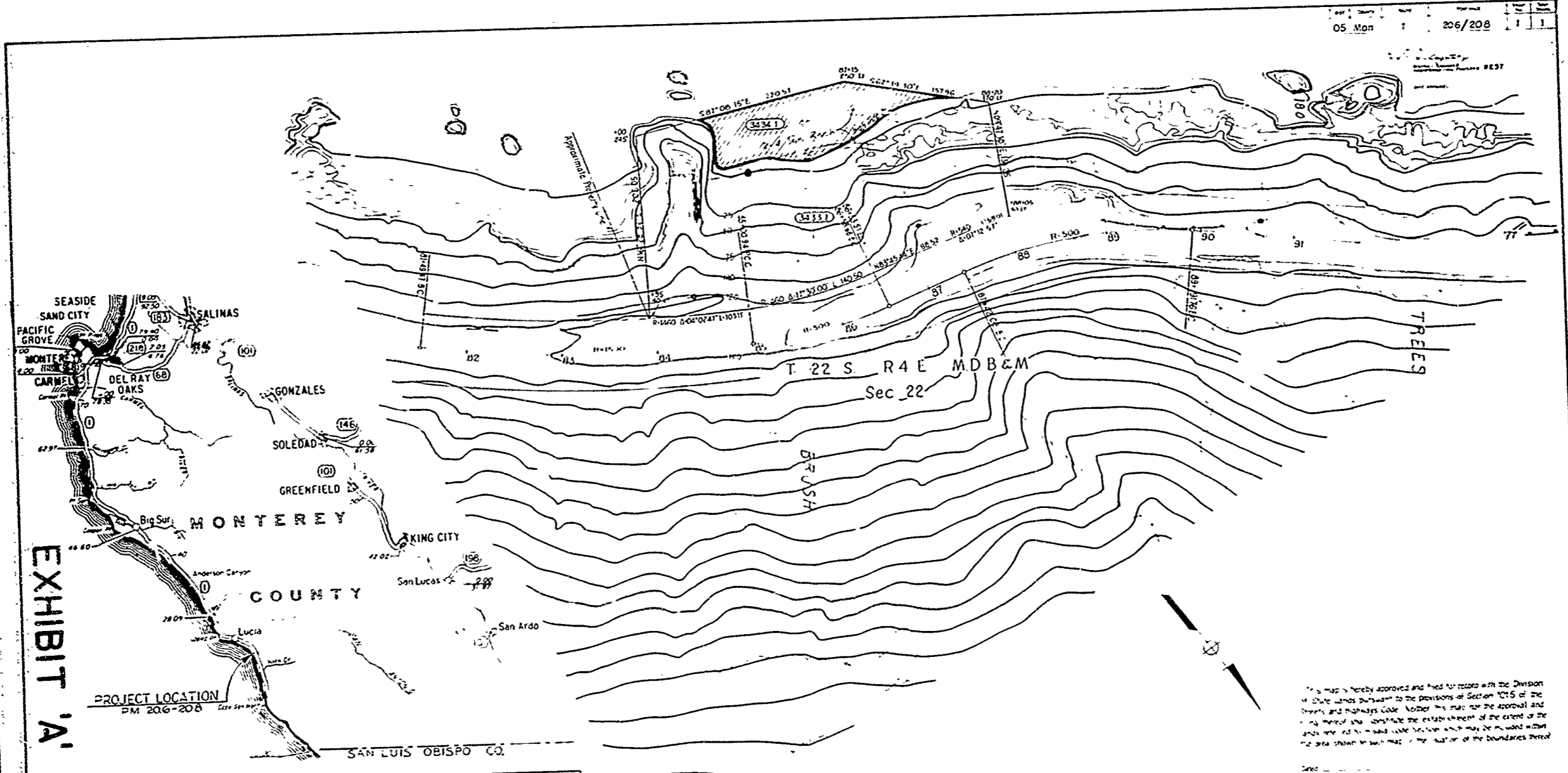
