FOURTH MODIFICATION OF THE 1.973-1974 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested Commission approval of the Fourth Modification of the Plan of Development and Operations and Budget, Long Beach Unit (July 1, 1973, through June 30, 1974) augmenting the investment portion of the Budget PART III.A.2.e.(7) Environmental Control, by \$48,000 to provide funds for the purchase of two oil spill containment booms.

These improved oil containment booms have been tested by the petroleum industry and recommended by the U.S. Coast Guard and the Petroleum Industry Coastal Emergency Cooperative for use in controlling O.I spills where sea conditions are similar to those in the vicinity of the Long Beach Unit's oil production islands.

With the approval of this modification the affected Budget Item will be adjusted as follows:
