

4. PUBLIC AGENCY PERMIT FOR AN INDEFINITE PERIOD, SOVEREIGN LAND IN THE BED OF THE OWENS RIVER EAST OF BIG PINE, INYO COUNTY; DEPARTMENT OF TRANSPORTATION, DIVISION OF HIGHWAYS - W 20652, PRC 4839.0.

After consideration of Calendar Item 2 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PUBLIC RESOURCES CODE 21080(b), 14 CAL. ADM. CODE 15032 AND 10 CAL. ADM. CODE 2905(j)(2).
2. AUTHORIZES THE ISSUANCE TO THE DEPARTMENT OF TRANSPORTATION, DIVISION OF HIGHWAYS, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF A PUBLIC AGENCY PERMIT FOR AN INDEFINITE PERIOD FROM DECEMBER 1, 1973; AND THE APPROVAL OF AN APPROPRIATE PLAT AUTHORIZING THE CONSTRUCTION OF A BRIDGE ACROSS A PARCEL OF SOVEREIGN LAND IN THE BED OF THE OWENS RIVER, AS DESCRIBED ON DIVISION OF HIGHWAYS MAP 09-INY-168-PM19.9 NO. 9800 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY PERMIT

APPLICANT: Department of Transportation, Division of Highways.

LOCATION: An approximately .235-acre parcel of sovereign land in the bed of the Owens River east of Big Pine, Inyo County.

LAND USE: A bridge serving State Route 168.

TERMS OF PROPOSED LEASE:  
Indefinite period, from December 1, 1973.

CONSIDERATION: The Division of Highways is required to deposit an amount representing the value of the right-of-way in the General Fund for credit to the Resources Protection Account. A reasonable estimate of the value of this parcel is \$100.

BASIS FOR CONSIDERATION:  
Chapter 1052, Statutes of 1969.
