A 462-square foot parcel of submerged land in the Sacramento River, Tehama County, approximately 400 feet northerly of the Glenn-Tehama County line.

LAND USE:

Floating boat dock.

TERMS OF PROPOSED LEASE:

5 years, from November 1, 1971.

Surety bond: \$500.

CONSIDERATION: \$50 per annum.
