15. CHANNEL MAINTENANCE DREDGING PERMIT, COYOTE CREEK NEAR MILL VALLEY, MARIN COUNTY; DEPARTMENT OF PUBLIC WORKS, MARIN COUNTY - W 9607, PRC 4914.9.

After consideration of Calendar Item 13 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

- DETERMINES THAT A FINAL ENVIRONMENTAL IMPACT REPORT HAS BEEN PREPARED FOR THE PROJECT BY THE DIVISION FOLLOWING EVALUATION OF COMMENTS AND CONSULTATION WITH PUBLIC AGENCIES WHICH WILL ISSUE APPROVALS FOR THE PROJECT.
- 2. CERTIFIES THAT THE FINAL ENVIRONMENTAL IMPACT REPORT (EIR #150) HAS BEEN COMPLETED IN COMPLIANCE WITH THE CALIFORNIA ENVIRONMENTAL QUALITY ACT OF 1970, AS AMENDED, AND THE STATE GUIDELINES, AND THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED THEREIN.
- 3. DETERMINES THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
- 4. AUTHORIZES THE ISSUANCE OF A PERMIT TO THE DEPARTMENT OF PUBLIC WORKS, MARIN COUNTY, TO DREDGE 25,000 CUBIC YARDS OF MATERIAL FROM A PORTION OF COYOTE CREEK, MARIN COUNTY (AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF), WITHOUT PAYMENT OF STATE ROYALTY, AND TO SPOIL THE DREDGED MATERIAL AT THE CORPS OF ENGINEERS APPROVED DUMP SITE NEAR ALCATRAZ ISLAND IN SAN FRANCISCO BAY, WITH ALL SUCH OPERATIONS TO BE CONDUCTED IN ACCORDANCE WITH THE FINAL ENVIRONMENTAL IMPACT REPORT FOR THE WORK, EFFECTIVE JUNE 6, 1974, TO DECEMBER 31, 1977.

CHANNEL MAINTENANCE DREDGING PERMIT

APPLICANT:

Department of Public Works, Marin County.

DREDGE LOCATION:

Coyote Creek, vicinity of Highway 101, near Mill Valley

(dredge area described in Exhibit "A").

LAND OWNERSHIP:

Granted to Marin County; minerals reserved to the State.

PROJECT:

Dredge, by clamshell bucket, and barge away 25,000 c.y. of

silt accumulated in creek channel.

PURPOSE:

Restore watershed channel for flood control.

DREDGE MATERIAL DISPOSAL:

All material to be spoiled at approved dump site near

Alcatraz Islar.d.

CONSIDERATION:

The putlic benefit.

OTHER PERTINENT DATA:

- 1. Channel originally dredged (1964) by the Corps of Engineers. County is legally required to maintain the channel in its agreement with the Corps.
- 2. Permits for the work have been issued by:
 - a. U. S. Army Corps of Engineers.
 - b. San Francisco Bay Conservation and Development Commission.
 - c. State Water Resources Control Board (certificate).
- 3. Pursuant to the California Environmental Quality Act of 1970, an environmental impact report draft, stating that the proposed work will not have a significant effect on the environment, was prepared and circulated by the Division. All comments received in response to the draft have been evaluated and incorporated in the final environmental impact report, EIR #150.
