## THE COMMISSION:

APPLICANT: Department of Transportation, Division of Highways.

AREA, TYPE LAND AND LOCATION:

An approximate 5.34-acre parcel of sovereign land in the bed of the Napa River near Suscol Hill, Napa County.

LAND USE:

Construction and maintenance of a bridge serving State Route 29.

TERMS OF PROPOSED LEASE:

Initial period: Indefinite period, from July 1, 1974.

CONSIDERATION: The Division of Highways is required to deposit an amount representing the value of the right-of-way in the General Fund for credit to the Resources Protection Account. In the opinion of the Division of Highways the value of this parcel is \$100.
