4. 10-YEAR PUBLIC AGENCY PERMIT, SCHOOL LAND IN SAN BERNARDINO COUNTY; STATE DEPARTMENT OF FISH AND GAME - W 20499, PRC 4920.2.

After consideration of Calendar Item 2 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PUBLIC RESOURCES CODE SECTION 21065; 14 CAL. ADM. CODE SECTION 15037; AND 2 CAL. ADM. CODE SECTION 2910.
2. AUTHORIZES THE ISSUANCE TO THE STATE DEPARTMENT OF FISH AND GAME OF A 10-YEAR PUBLIC AGENCY PERMIT FROM JUNE 1, 1974, AS AUTHORIZED BY SECTION 308.5 OF THE FISH AND GAME CODE; FOR THE POSTING OF SPECIFIED SIGNS NEAR WATER HOLES LOCATED ON STATE SCHOOL LANDS DESCRIBED AS:

SECTION 36, T 15 N, R 16 E, SBM; SECTION 16, T 11 N, R 14 E, SBM; SECTION 36, T 7 N, R 12 E, SBM; AND SECTION 36, T 4 N, R 20 E, SBM, SAN BERNARDINO COUNTY;

SAID SIGNS SHALL ENJOIN THE PUBLIC NOT TO CAMP, PICNIC OR STAY WITHIN 200 YARDS OF THE POSTED WATER HOLE; AND PROVIDED FURTHER THAT SUCH PERMIT SHALL NOT CONVEY ANY PROPERTY RIGHTS OTHER THAN AUTHORITY FOR POSTING OF THE SIGNS.

PUBLIC AGENCY PERMIT

APPLICANT: State Department of Fish and Game.

AREA, TYPE LAND AND LOCATION:

Four parcels of State school land located in Section 36, T 15 N, R 16 E; Section 16, T 11 N, R 14 E; Section 36, T 7 N, R 12 E; and Section 36, T 4 N, R 20 E; all in SBM, San Bernardino County.

LAND USE: Posting of specified signs limiting use by the public.

TERMS OF PROPOSED LEASE:

Initial period: 10 years, from June 1, 1974.

CONSIDERATION: The public benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Div. 6, Parts 1 and 2.
- b. Administrative Code: Title 2, Div. 3, Arts. 1, 2 and 10.
- c. Fish and Game Code: Section 308.5.

OTHER PERTINENT INFORMATION:

1. The annual rental value of the site is estimated to be \$20.
2. The Department of Fish and Game has applied to the State Lands Commission for authorization to place restrictive signs near various water holes in San Bernardino County. The signs are designed to limit public use thereof, in order to protect and preserve wildlife.

Inasmuch as placement of the signs is not a "project" as defined in the State Guidelines for implementation of CEQA, an environmental impact report is not required. The permit authorizing the posting of the various water holes will grant no rights in the property other than to place the authorized signs.
