27. BORROW PERMIT, TIDELANDS IN THE CITY OF DEL MAR, SAN DIEGO COUNTY;
CITY OF DEL MAR - W 9781, PRC 4974.

After consideration of Calendar Item 27 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF 2 CAL. ADM. CODE 2910.
2. RATIFIES THE ACTION OF THE EXECUTIVE OFFICER'S ISSUANCE TO THE CITY OF DEL MAR OF A BORROW PERMIT FOR THE EXTRACTION OF 10,000 CUBIC YARDS OF MATERIAL FROM AN AREA OF STATE TIDELANDS; FOR USE IN REPAIRING AN ADJACENT EXISTING SAND BERM SEA BARRIER; IN CONSIDERATION OF THE PUBLIC BENEFIT WITH NO ROYALTY REQUIREMENTS; EFFECTIVE OCTOBER 25, 1974, TO MARCH 25, 1975, UNLESS SOONER TERMINATED BY THE COMMISSION; SUCH PERMISSION TO BE CONDITIONAL UPON THE ISSUANCE AND REQUIREMENTS THEREIN OF PERMITS FOR THE WORK BY THE U. S. ARMY CORPS OF ENGINEERS, THE STATE DEPARTMENT OF PARKS AND RECREATION, THE STATE DEPARTMENT OF FISH AND GAME, AND THE STATE COASTAL ZONE CONSERVATION COMMISSION.

BORROW PERMIT

APPLICANT: City of Del Mar.

PROPOSED PROJECT: Excavation of 10,000 cubic yards of beach material (by skip loader) from the plus 1.0 foot above M.L.L.W. zone, for use in repair of an existing sand berm sea barrier along the Del Mar beach front.

PURPOSE: Sea barrier protection of both public and private property.

TERMS: October 25, 1974, to March 25, 1975, unless sooner terminated by Commission.

CONSIDERATION: Public benefit, with no royalty requirements.

ENVIRONMENTAL IMPACT CONSIDERATION:

The project is exempt from environmental impact report requirements under the provisions of 2 Cal. Adm. Code 2910, "Minor Encroachment Permit", which allows rebuilding or repair of levees or other protective structures including minor dredging for materials.

OTHER PERTINENT DATA:

1. In November 1973, under State Permit PRC 4824.9, the City constructed the sand berm to prevent winter wave and breaker action from eroding away the adjacent land banks fronting both privately- and City-owned lands. The City has now determined that last winter's sea action and last summer's beach usage by the public have damaged the berm to the extent that repair will be required in order to reestablish its sea barrier effectiveness.
2. In order to retain as much protective expanse of beach in front of the berm as possible, the proposed excavation must be conducted during a period of lower low tide. Since a period of very low tides will occur this coming November, the City requested the Executive Officer to authorize the berm repair work on October 25, 1974, and the Executive Officer so authorized, in order that contracts and procedures could be initiated for commencement of the work in early November.

3. The City has been instructed to secure the necessary approvals from the U. S. Army Corps of Engineers, the State Department of Parks and Recreation, the State Department of Fish and Game, and the State Coastal Zone Conservation Commission. The permit was made conditional to the issuance of such permits.
