COMMENCING at an iron pipe marking the northwest corner of Lot 9, Block 4, as shown on the map entitled "MAP OF THERMALITO; BUTTE COUNTY, CALIFORNIA", filed in the Office of the Recorder of said County on June 8, 1887; thence N 62° 25' 00" E, 37.91 feet along the southerly line of Grand Avenue; thence S 29° 39' 25" E, 86.11 feet; thence S 48° 33' 20" E, 249.21 feet; thence S 33° 27' 05" E, 552.22 feet to the TRUE POINT OF BEGINNING; thence S 14° 12' 45" E, 847.28 feet to a point being the end of the herein described centerline, said point bears S 66° 22' 00" W, 17.70 feet; N 22° 54° 15" W, 340.22 feet; N 12° 39' 50" W, 148.65 feet and N 11° 00' 35" W, 223.03 feet from a brass cap monument marking the intersection of the centerlines of Montgomery Street and Pine Street.
