7. RIGHT-OF-WAY FOR INDEFINITE PERIOD, SUBMERGED LAND IN THE BED OF THE COLORADO RIVER, SAN BERNARDINO COUNTY; CONTINENTAL TELEPHONE COMPANY OF CALIFORNIA - W 20731, PRC 5004.

After consideration of Calendar Item 5 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21080; 14 CAL. ADM. CODE 15073; AND 2 CAL. ADM. CODE 2910.
2. AUTHORIZES THE ISSUANCE TO CONTINENTAL TELEPHONE COMPANY OF CALIFORNIA OF A RIGHT-OF-WAY FOR AN INDEFINITE PERIOD FROM JANUARY 1, 1975; PURSUANT TO PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE; FOR A BURIED COMMUNICATIONS CABLE; ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

RIGHT-OF-WAY

APPLICANT: Continental Telephone Company of California.

AREA, TYPE LAND AND LOCATION:
A 10' x 450' parcel of submerged land in the bed of the Colorado River, 8 miles south of Parker Dam, San Bernardino County.

LAND USE: Buried communications cable.

TERMS OF PROPOSED LEASE:
Initial period: Indefinite period, from January 1, 1975.

CONSIDERATION: Exempt by law pursuant to Section 7901 of the Public Utilities Code.

PREREQUISITE TERMS:
Applicant is lessee or permittee of upland.

STATUTORY AND OTHER REFERENCES:
a. Public Resources Code: Div. 6, Parts 1 & 2.
b. Administrative Code: Title 2, Div. 3, Arts. 1, 2 & 10.
c. Public Utilities Code: Section 7901.

OTHER PERTINENT INFORMATION:
1. The project is exempt from the payment of a monetary consideration pursuant to Section 7901 of the Public Utilities Code.
2. The project is for the installation and maintenance of a communications cable and is ministerially exempt from CEQA, as amended, pursuant to 2 Cal. Adm. Code 2910.

EXHIBIT "A"

W 20731

A 10-foot wide strip of land across that portion of the Colorado River owned by the State of California by virtue of its sovereignty, said strip being a portion of a longer strip located 5 feet on each side of the following described centerline:

COMMENCING at a U.S.G.L.O. monument set at the northwest corner of Section 36, T 2 N, R 26 E, SBM; thence N 89° 59' 00" E along the north line of said Section 36, 1320.99 feet to a U. S. Cadastral Survey monument set at the W-1/16 corner of said Section 36; thence N 78° 00' 09" E, 1641.41 feet to the TRUE POINT OF BEGINNING; thence S 39° 10' 10" E, 461.00 feet; thence S 31° 34' 44" E, 844.60 feet to the end of the herein-described centerline.
