THE COMMISSION:

- 2. AUTHORIZES ISSUANCE TO LOS ANGELES COUNTY FLOOD CONTROL DISTRICT OF A 49-YEAR PUBLIC AGENCY PERMIT FROM SEPTEMBER 1, 1969; IN CONSIDERATION OF THE PUBLIC HEALTH AND SAFETY, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE OPERATION AND MAINTENANCE OF AN EXISTING 10' x 7' REINFORCED CONCRETE BOX CULVERT FOR STORM WATER DRAINAGE; ON THE LAND DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

# PUBLIC AGENCY PERMIT

APPLICANT:

Los Angeles County Flood Control District P. O. Box 2418, Terminal Annex Los Angeles, California 90051

AREA, TYPE LAND AND LOCATION: A 0.09-acre parcel (50' x 200' +) of tide and submerged land adjacent to Will Rogers State Beach, Los Angeles County.

LAND USE: Operation and maintenance of an existing 10' x 7' reinforced concrete box culvert for storm water drainage.

TERMS OF PROPOSED LEASE: Initial period: 49 years, from September 1, 1969.

CONSIDERATION: The public health and safety, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES: Applicant is lessee of upland.

STATUTORY AND OTHER REFERENCES:
