THE COMMISSION:

- 1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21065; 14 CAL. ADM. CODE 15037; AND 2 CAL. ADM. CODE 2910.
- 2. AUTHORIZES THE ISSUANCE TO CHARLES A. KENWORTHY, DBA "THE QUEST", OF A ONE-YEAR RENEWAL OF AN EXPLORATORY PERMIT FROM AUGUST 8, 1975, WITH LESSEE'S OPTION TO RENEW FOR ONE SUCCESSIVE PERIOD OF ONE YEAR; IN CONSIDERATION OF RENT IN THE AMOUNT OF \$300 FOR THE SOLE PURPOSE OF SEARCHING FOR AND IDENTIFYING ABANDONED PERSONAL PROPERTY NO SALVAGE BEING AUTHORIZED ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, PROVIDED THAT REMOVAL OF FOUND PROPERTY, OR OTHER DISTURBANCE OF THE OCEAN FLOOR SHALL NOT BE AUTHORIZED.

APPLICANT: Charles A. Kenworthy dba The Quest 18400 Ventura Boulevard Tarzana, California 91356

AREA, TYPE LAND AND LOCATION: Two parcels (5,946 and 3,395 acres) adjacent to Santa Catalina Island, Los Angeles County.

LAND USE: Search for and identify abandoned treasure. No salvage authorized.

TERMS OF ORIGINAL LEASE:

Initial period: One year, from August 8, 1974.

Renewal Options: 2 successive periods of one year each.

Consideration: \$300.

TERMS OF RENEWAL:

One year from August 8, 1975.

Remaining Renewal Option: One successive period of one year.

CONSIDERATION: \$300.

STATUTORY AND OTHER REFERENCES: a. Public Resources Code: Div. 6, Parts 1 & 2.

OTHER PERTINENT INFORMATION:

The proposed renewal will not change any of the provisions of the original permit. No salvage operations are authorized and, therefore, no disturbance or effect on the environment is envisioned. The proposal is, therefore, classed as a "Non-Project" and pursuant to environmental laws an environmental impact report is not required.

Two parcels of tide and submerged land adjacent to Santa Catalina Island, Los Angeles County, State of California, being more particularly described as follows:

PARCEL A

BEGINNING at a point offshore of Blue Cavern Point on Santa Catalina Island said point being located at $33^{\circ} 27' 40''$ north latitude, 118° 28' 10'' west longitude; thence N 64° 15' W 24,000 feet; thence S 25° 45' W 600 feet more or less to the ordinary high water mark near Parson's Landing; thence southeasterly along said ordinary high water mark to point that bears S 25° 45' W from the point of beginning; thence N 25° 45' E 5,000 feet more or less to the point of beginning.

PARCEL B

BEGINNING at a point offshore of Spring Landing on Santa Catalina Island said point being located at $33^{\circ} 24' 50''$ north latitude, $118^{\circ} 36' 20''$ west longitude; the ce S $63^{\circ} 45' E 18,500$ feet; thence N $26^{\circ} 15' E$ 14,900 feet more or less to the ordinary hig. water mark in the vicinity of Lobster Bay; thence northwesterly along said ordinary high water mark to a point that bears N $26^{\circ} 15' E$ from the point of beginning; thence S $36^{\circ} 15' W 15,500$ feet more or less to the point of beginning.

EXCEPTING THEREFROM those lands currently under lease from the State Lands Commission to the University of Southern California under PRC 3692.1.
