CONTRACTOR: Standard Oil Company of California Western Operations, Inc. 225 Bush Street San Francisco, California 94104

**PURPOSE:** In accordance with the Commission's directive of January 14, 1975, Standard Oil Company has requested that the State Lands Division solicit proposals for the preparation of an Environmental Impact Report for the proposed resumption of drilling by Standard Oil in the Santa Barbara Channel which will comply with the California Environmental Quality Act, as amended, and be acceptable to the State Lands Commission. Standard Oil Company agrees to pay the State Lands Division, upon execution of this contract, the total allowable cost of \$42,000 which represents the contract cost of the lowest acceptable bidder, Woodward-Clyde Consultants, Inc.

CONTRACT TERMS: Time: Payment by Standard Oil Company of California to the State Lands Division must be made upon execution of this agreement.

Cost: Total allowable costs for services to be rendered not to exceed \$42,000.
