34. SUBVENTIONS TO CITIES AND COUNTIES FOR THE 1974-1975 FISCAL YEAR - W 4848.

After consideration of Calendar Item 32 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE REPORTING TO THE STATE CONTROLLER OF THE SUBVENTIONS FOR THE 1974-1975 FISCAL YEAR THAT ARE ATTRIBUTABLE TO THE REVENUES RECEIVED FROM LEASES WITHIN THE LIMITS OF QUALIFYING CITIES OR COUNTIES ACCORDING TO THE PARKS AND MILEAGE AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

SUBVENTIONS TO CITIES AND COUNTIES  
FOR THE 1974-1975 FISCAL YEAR

DESCRIPTION: Section 6817 of the Public Resources Code provides for subventions of State tide and submerged land oil and gas revenues to cities and counties, under conditions described below, and requires the State Lands Commission to report to the State Controller the amounts of the revenues to be used for purposes of calculating the subventions.

PURPOSE: To approve qualifying beaches and parks, as required in Public Resources Code Section 6817 (Chapter 2160, Statutes of 1963) as enumerated in Exhibit "A" attached.

## OTHER PERTINENT INFORMATION:

The salient features of Chapter 2160, Statutes of 1963, are:

1. The subventions shall be made to cities or counties that own or operate parks (public beaches) free of charge to the public for recreational purposes, which parks must be offset by tide and submerged land oil and gas leases let by the Commission immediately adjacent to and having a common frontage with the parks.
2. The subvention for each fiscal year shall amount to one percent of the State's total revenue from leases lying offshore but within the limits of the particular city or county, to a maximum of \$75,000 for each mile or fraction of a mile of ocean frontage of park qualifying under No. 1 above.
3. The apportionment for any given fiscal year shall be based upon the physical facts existing on June 30 of the preceding fiscal year with respect to each city or county.
4. The State Lands Commission shall, at the time of remitting revenues to the State Treasury, report to the State Controller the total amount of revenue received from tide and submerged lands shown with respect to each city or county to which such amount is applicable.

5. The legislation provides that "The report of the State Lands Commission and the apportionments of the Controller shall be final."

The Division has investigated all parks and beaches owned or operated by cities and counties to which Chapter 2160, Statutes of 1963, might apply for the 1974-1975 fiscal year, and has found the following changes from the previous year.

The State of California's Department of Parks and Recreation has purchased three miles of the Huntington Beach public beach, and it has been determined that the remaining mile does not qualify for subvention apportionment. The City of Huntington Beach has questioned State Lands Division staff as to this decision. The Office of the Attorney General was asked to resolve the issue and on June 26, 1975, concurred that staff of the Division had properly interpreted the statute.

The County of Ventura has added the Whitton addition amounting to an additional 698 feet.
