INDUSTRIAL LEASE; TIDE AND SUBMERGED LAND IN THE GULF OF 14. SANTA CATALINA, SAN DIEGO COUNTY; SOUTHERN CALIFORNIA EDISON COMPANY AND SAN DIEGO GAS AND ELECTRIC COMPANY; WP 4648; PRC 4648.

William F. Northrop, Executive Officer, gave a brief summary of the background of the Item. He stated that the applicant wished to continue a lease for 12 existing floating buoys, anchor blocks and scientific monitoring devices; and to install 14 additional floating buoys, anchor blocks and scientific monitoring devices as a study for an expansion of a power plant at San Onofre.

Robert C. Hight, Staff Counsel, explained the lease could provide that these monitoring buoys do not in anyway bind the Commission as to future leases.

The Commission further instructed that the lease should contain a provision that the subject lease will not bind the Commission in any way relative to further lease proposals by Southern California Edison Company and San Diego Gas and Electric Company.

Upon motion duly made and carried, the following resolution was adopted:
