AREA, TYPE LAND AND LOCATION: A 330 square foot parcel of submerged land in Lake Tahoe near Tahoe City, Placer County.

LAND USE: Existing recreational pier.

TERMS OF PROPOSED LEASE: Initial period: 5 years from December 27, 1973.

Surety Bond: \$1,000.

CONSIDERATION: \$75 per annum.

BASIS FOR CONSIDERATION: \$75 fixed rental for this type of permit, at the date the applicant executed the Divisionprepared document.

PREREQUISITE TERMS, FEES AND EXPENSES: Applicant is owner of upland.

Filing fee has been received.

The rent has been paid from December 27, 1973 to December 26, 1976.

2. It is an express condition subsequent of this permit that if any structure hereby authorized is found to be in non-conformance with the Tahoe Regional Planning Agency's Shorezone Ordinance and if any alterations, repairs, or removal required pursuant to

said Ordinance is not accomplished within the designated time period, then this permit is automatically terminated, effective upon notice by the State, and the site shall be cleared pursuant to the terms thereof.

- 3. It is an express condition of this permit that if any structure or appurtenances hereby authorized are found to be situated upon or adjacent to land of the county of Placer without their consent and approval, then this permit is automatically torminated, effective upon notice by the State, and the site shall be cleared pursuant to the terms herein.
- 4. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a significant use category, Class B: Limited Use. Staff review indicates there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.
- 5. An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property shoreline erosion, or other types of environmental degradation.
