OTHER PERTINENT INFORMATION:

- This lease is for the continuance of an existing pier which has been under lease since 1949. The pier is in a good state of repair and there is no indication of damage to the environment.
- 2. This area has been classified as having significant environmental values even though this pier was and is still in full operation as a commercial fishing pier.
- 3. This project is situated on State land identified as possessing significant environmental values, pursuant to Fublic Resources Code 5360.1, and is classified in a significant use category, Class A. Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.
- 4. An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a), which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
