NON-COMMERCIAL LEASE AND SETTLEMENT OF PEOPLE V. ELKHORN BOAT CLUB, INC.

On October 6, 1975, the State Lands Division staff taled suit against the Hikhorn Boat Club, Incorporated. The suit sought ejectment and damages for the unlawful uso of State property.

Subsequently, the Division received a settlement offer of 11,962 to settle the back rental and an agreement to enter into a lease for the future use of the State lands. The Division staff has received the sum of \$2,566 which represents the settlement offer plus rental for two years. The staff is of the opinion that the proposed settlement and lease is in the best interests of the State.
