AREA, TYPE LAND AND LOCATION:

A 62' x 211' (.31 acre) parcel of tide and submerged land in the bed of the Sacramento

River, Sacramento County.

LAND USE:

The construction of rip rap bank protection.

TERMS OF PROPOSED PERMIT:

Initial period: 25 years, from September 1, 1976.

CONSIDERATION:

\$192 per annum, with the State reserving the right to fix a different rental on each fifth

anniversary of the lease.

BASIS FOR CONSIDERATION:

8% of appraised value of land.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee and Environmental costs have been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:

- 1. During the circulation of an Initial Study for this project, the County of Sacramento objected to the issuance of a permit for this project. The County's objection was not based on environmental considerations but on a possibility that the County may wish to acquire this property at some future date. Staff feels that the County's objection has no validity to the environmental issues on the project.
- 2. This project is situated on State land identified as environmentally significant, pursuant to Public Resources Code 6370.1,
