PUBLIC AGENCY PERMIT

APPLICANT:

Humboldt Bay Wastewater Authority

AREA, TYPE LAND AND LOCATION:

Two parcels of tide and submerged land in the Pacific Ocean (5,204 acres) and Mad River

(0.576 acres), Humboildt County.

LAND USE:

Construction and maintenance of a 42" diameter

ocean outfall and interceptor crossing;

temporary construction easement.

TERMS OF ORIGINAL MEASE:

Initial period: 49 years, from December 27, 1976.

CONSIDERATION:

The public health and safety, with the State reserving the right at any time to set a

monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is permittee of upland.

Processing costs have been received.

STATUTORY AND OTHER REFERENCES:

Public Resources Code: Div. 6, Parts 1 & 2. a.

Administrative Code: ·b.

Title 2, Div. 3, Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:

The annual rental value of the site is estimated to be \$500.

A portion of this project is situated on State land identified as environmentally significant, pursuant to Public Resources Code 6370.1. That portion is classified in a significant use category, Class A: Restricted Use. Staff has coordinated this project with those making the nomination. The project is determined to be a compatible use consistent with identified significant environmental values.

- AUTHORIZE ISSUANCE TO HUMBOLDT BAY WASTEWATER AUTHORITY OF A 49-YEAR PUBLIC AGENCY PERMIT FROM DECEMBER 27, 1976; IN CONSIDERATION OF THE PUBLIC HEALTH AND SAFETY, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONE-TARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR CONSTRUCTION AND MAINTEN-ANCE OF A 42" DIAMETER OCEAN OUTFALL AND INTERCEPTOR CROSSING ON THE LAND DESCRIBED IN PARCELS 2 AND 3 ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
- AUTHORIZE THE INCLUSION IN THE LEASE OF A TEMPORARY CONSTRUCTION EASEMENT, 300 FEET WIDE, DESCRIBED IN PARCEL 1 OF EXHIBIT "A" ATTACHED; PROVIDED THAT SAID TEMPORARY EASEMENT SHALL EXPIRE TWO YEARS AFTER THE BEGINNING DATE OF THE LEASE.

EXCEPTING THEREFROM any portion thereof lying landward of the ordinary high water mark of the Pacific Ocean.

A parcel of land lying in the state owned bed of the Mad River, Humboldt PARCEL 3 County, State of California, being within the NE 1/4 of the NE 1/4 of Section 12, T 6 N, R 1 W, HBM, said parcel being 66 feet wide and lying 33 feet on each side of the centerline of the main track of the California
