MODIFICATION OF EXISTING DREDGING PERMIT

PERMITTEE:

Gity of Vallejo 734 Marin Street Vallejo, California 94590

RESUME OF PREVIOUS ACTION:

Permit PRC 5009.9 to initially dredge 360,000 cubic yards of material and therefter maintenance dredge 25,000 cubic yards per year, at no royalty, from an area of State tidelands adjacent to the City of Vallejo waterfront, was issued on April 30, 1975. The State Lands Commission determined that an Environmental Impact Report had been prepared for this project and certified by the City of Vallejo on January 22, 1975. All of the dredged material is to be spoiled at (1) Carquinez Strait, Contra Costa County, and (2) Alcatraz Island, San Francisco County.

PROPOSED MODIFICATION:

A letter dated April 13, 1976, requested an amendment of Dredging Permit PRC 5009.9 to allow for the dredging of an additional 300,000 cubic yards of material.

The additional volume to be dredged does not reflect any greater surface area of dredging than originally contemplated, and is required because of the necessity, due to engineering problems, to substitute a steel sectioned cellular cofferdam for the originally proposed concrete dock, which requires a greater dredge depth. Since the project will not be extended beyond the original approved aerial extent, all agencies involved have approved the requested additional amount, and therefore, no further environmental consideration is deemed necessary.
