2. This project is situated on State land identified as possessing significant environmental values, pursuant to Public Résources Code 6370.1, and is classified in a significant use category, Class B.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

- This facility was originally installed in June 1972, as an emergency facility in order to provide an alternate source of power to pumps protecting Tyler Island from flooding. The prime source of power Andrus Island which was flooding due to a levee break and the power line was in danger of failing.

Provisions allowing the inclusion of "wheeling" language within this amendment have not been included. "Wheeling" has application only to high-voltage transmission facilities. The facilities covered by this proposed Right-of-Way Lease are distribution facilities for Tyler Island only and, therefore, would have no use under proposed "wheeling" regulations.
