PERMIT TO CONSTRUCT TEMPORARY LEVEES (WING DAMS.) ON THE KLAMATH RIVER

APPLICANT:

Deil Norte County Department of Public Works Crescent City, California 95531

PROPOSED PROJECT:

The Department of Public Works proposes to annually construct, over a ten-year period, channel training levees (wing dams) on the Klamath River. When complete, the wing dams will be no more than 400 feet in length and 4 feet to 7 feet in height.

PURPOSE :

The proposed project is intended to permit mavigation and improve fishing access during the summer months.

SPOLLS PEACEMENT:

Approximately 5,000 cubic yards of river rock, gravel, and sand would be used for the dam construction. The material used will be rearranged in the construction of the dams but will not be removed from sovereign land.

CONSIDERATION:

Public interest -- no royalty required.

ENVIRONMENTAL IMPACT CONSIDERATION:

The applicant acting as the lead agency, prepared a negative declaration environmental document, SCH 76072710, and has determined that the project will not have a significant effect on the environment. This document has been filed with the State Clearinghouse.

The project is situated on State land identified as possessing significant environmental values, pursuant to Section 6370.1, of the Public Resources Code, and is classified in a significant use category, Class A: Restricted Use. Staff review indicates that there will be no significant effect upon identified environmental values.

OTHER PERTINENT INFORMATION:

- This project was originally proposed by the Klamath Chamber of Commerce, however, the Del Norte County Department of Public Works assumed the project responsibility.
- The following conditions requested by the State Secretary of Resources will be included in this permit:
  - A. The State Department of Fish and Game will issue an annual approval of the project.
  - B. No excavation will be made within fifteen feet of any highway bridge piers. In addition, within 100 feet of the bridge, total width of project from outside to outside of wing dams, shall be within the limits of one span of the bridge.
  - G., Wing dams will be marked with appropriate buoys, as requested by the Department of Navigation and Ocean Development.
