The State Lands Com ission issued Lease PRC 1532,2, a Right of Way Easement, to Scott Lumber Company, Inc., on August 29, 1955, for a term of 49-years, unless sooner terminated in accordance to provisions of the lease, commencing June 27, 1955. Said lease embraced State school land located in Shasta County, State of California, described as fullows:

A 30-foot right of way easement extending diagonally across the southwest corner of the southwest quarter of Section 16, T35N, RSE, M.D.M., being 300 feet, more or less, in length.

The total rental of \$50 was paid in full by Scott Lumber Company, Ind., upon their execution of the lease.

On December 27, 1968, Scott Lumber Company, Inc., merged into Publishers Forest Products Company of California, By letter of October 15, 1976, Publishers Forest Products Company of California gave whitten notice that the company no longer needed the subject right of way easement.

For the purpose of terminating Lease PRC 1532.2, a quitical document was prepared by the Division and transmitted to the Company. Rublishers Forest Products of California, through duly authorized officers of the corporation, has executed and submitted for acceptance of the State Lands Commission a Lease Quitclaim Deed, which deed is on file with the office of the State Lands Division and by reference made a part

The demised premises, during the past 21 years of the 49-year term of the Tease, were used only for lawful commercial purposes, construction and maintenance of a roadway.
