MODIFICATION OF EXESTING DREDGENG PERMIT

RESUME OF PREVIOUS ACTION:

Dredging Permit PRG 5071.1, to perform maintenance dredging of approximately 43,000 cubic yards from tide and submerged lands in San Francisco Bay at Richmond, adjacent to Richmond Long Wharf, was issued on October 29, 1975. The spoids were to be disposed of at the San Francisco Bay Disposal Site south of Alcatraz Island. The Permit was to be effective for the term commencing on October 29, 1975 and terminating on December 31, 1976. There is a royalty of \$.10 per cubic yard on minerals removed from sovereign land. Subsequently, Standard awarded a contract to Healy-Tibbitts Construction Coo, to perform this dredging work during the early part of 1976, but due to numerous operational problems and equipment breakdown delays encountered by their contractor, this dredging work had to be delayed repeatedly to the extent that the dredging did not commence until the early part of October 1976.

PROPOSED MODIFICATION:

In a letter dated October 14, 1976, Standard requested an extension to April 30, 1977 of the term of Permit PRC 5071.1, which is due to expire on December 31, 1976.

The request for the extension of time on this project has been discussed with the concerned agencies with no adverse comments received.

ENVIRONMENTAL IMPACT CONSIDERATION.

- An Environmental Impact Report is not required. This project is within the purview of 2 Cal. Adm. Code 2907, Class 4, which exempts a maintenance dredging operation.
- This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Gode 6370.1, and is classified in a significant use category, Class C: Multiple Use.
