AREA, TYPE LAND AND LOCATION:

An 0.09-acre parcel of submerged land in Lake

Tahoe near Sunnyside, Placer County.

LAND USE:

Maintenance and reconstruction of an existing pier for recreational boating.

TERMS OF PROPOSED PERMIT:

Thitial period: 10 years from November 5, 1975.

Special:

- If any structure hereby authorized is found to be in nonconformance with the Tahoe Regional Planning Agency's Shorezone Ordinance and if any alterations, repairs, or removal required pursuant to said Ordinance is not accomplished within the designated time period, then this permit is automatically terminated, effective upon notice by the State, and the site shall be cleared pursuant to the terms thereof.
- 2. As a supplement to Paragraph 6 of Section 5, Permittee hereby agrees that on completion pending litigation over the State's boundaries, the State has the right to revise the rate and amount of the annual rental in addition to the rights stated in Paragraph 2 of Section 5 hereof. together with the right to approve existing improvements and fills in place.

CONSTRERATION:

\$630.40 per annum from November 5, 1975 through November 4, 1976; \$248.10 from November 5, 1976 through November 4, 1977; and \$70 per annum thereafter with the State reserving the right to fix a different rental on each fifth annivsary of the lease.
