ASSIGNMENT OF RIGHT OF WAY

ASSIGNOR: Hastings Farms

ASSIGNEE: Knob Hill Mines, Inc.

AREA, TYPE LAND AND LOCATION:  
1.37 acre parcel of tide and submerged land  
in Lindsey Slough adjoining Hasting Island  
Tract and Egbert Tract, Solano County.

LAND USE: Operation and maintenance of an existing bridge.

TERMS OF ORIGINAL LEASE:  
Initial period: 15 years from October 1, 1963.  
Surety bond: \$2,500.  
Consideration: \$72.82.

CONSIDERATION: \$72.82 per annum.

BASIS FOR CONSIDERATION:  
0.0662% of appraised value of land.

PREREQUISITE TERMS, FEES AND EXPENSES:  
Applicant is owner and permittee of upland.  
Filing fee and processing costs have been received.

STATUTORY AND OTHER REFERENCES:  
A. Public Resources Code: Div. 6, Parts 1 & 2.

OTHER PERTINENT INFORMATION:

and there is no evidence of record to  
show injury to adjacent property, shore-  
line erosion or other types of environ-  
mental degradation.

2. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class B which authorizes Limited Use.
3. Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

AUTHORIZE APPROVAL OF AN ASSIGNMENT OF RIGHT OF WAY LEASE PRC 3323.1 COVERING A 1.37 ACRE PARCEL OF TIDE AND SUB-MERGED LAND IN LINDSEY SLOUGH, SOLANO COUNTY, FROM HASTINGS FARMS TO KNOB HILL MINES INC., DBA: HASTINGS ISLAND LAND COMPANY; ANNUAL RENT IN THE AMOUNT OF \$72.82; PROVISION OF A \$2,500 SURETY BOND; FOR OPERATION AND MAINTENANCE OF AN EXISTING BRIDGE, ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
