SECOND MODIFICATION OF THE 1977-78 PLAN OF
DEVELOPMENT AND OPERATIONS AND BUDGET,
LONG BEACH UNIT, WILMINGTON OIL FIELD,
LOS ANGELES COUNTY

The City of Long Beach has requested that the State Lands Commission approve the Second Modification of the Plan of Development and Operations and Budget of the Long Beach Unit for the period July 1, 1977 through June 30, 1978. The Modification is submitted in accordance with PART IV, Section A-1 of the 1977-1978 Plan and Budget.

This Modification would permit the City Manager of Long Beach to designate in writing a public officer who would exercise on his behalf any approvals required of the City Manager in PART IV Procedures of the Plan and Budget. These approvals are required for the following items:

1. Modification of the Plan and Budget.
2. Modification of Exhibits to the Plan and Budget.
3. Approval of bottom hole locations of new wells.
4. Approval of change in status of any well as a producer or injector.
5. Approval of the redrill or abandonment of a well.
6. Approval of conversion to producing or injection status.
7. Approval of budget fund transfers between Budget Divisions or Major Budget Classes.
8. Approval of Augmentation of Budget or Budget Contingency Funds.
9. Presentation of carryover of Budget investment projects to Executive Officer, State Lands Commission.

The City of Long Beach advises that approval of this Second Modification would facilitate approval procedures for Long Beach Unit items. The Division has reviewed the Second Modification and has determined that the State's approval procedure will remain unchanged and that the Modification will have no fiscal impact. The Attorney General's office finds the Modification is legally sufficient and that it may be approved by the Commission.

CALENDAR ITEM NO. 30. (CONTD)

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE SECOND MODIFICATION OF THE PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1977 THROUGH JUNE 30, 1978.

In accordance with PART IV A.4.c of the 1977-1978 Plan of Development for the Long Beach Unit, the following Plan Supplements for additional projects under the \$100,000 have been approved by the General Manager, Department of Oil Properties, City of Long Beach and the Manager, Long Beach Operations, State Lands Division, and are hereby reported to the Commission and incorporated in the Plan. Funding for these Plan Supplements has been provided by specific Budget Items or by transfer within the existing Budget. Plan supplements do not require action by the Commission.

- No. 1: Install a drillable bridge plug in well G-317 above the 237 Zone, perforate the Union Pacific-Ford Zone and return the well to production. The estimated cost is \$65,400.
- No. 2: Equip Tar Zone well J-171 and return it to production. The estimated cost is \$28,500.
