APPROVAL OF THE EMERGENCY SALE OF INSECT DAMAGED TIMBER

On September 20, 1977, the Division was advised of an outbreak of bark beetles in timber near Shingletown, Shasta County. Subsequent examination by the Staff has disclosed that some of the infested trees are on about 3 acres of State School land in SW2 NE2 Section 2, T 30 N, R 1 E, MDM. The 21 infested second growth pine trees total 21,000 board feet of salvageable material. In order to stop the spread of the infestation, it is important that the infested trees be removed and slash burned as soon as possible. Shasta Resources Corporation intends to remove infested timber this Fall from the adjacent private land and it would be less costly to log both the State's timber and the private timber at the same time because of the small volume of material involved. They have offered to purchase the State's infested timber for \$32 per MBF or a total of \$672. The Staff has concluded this is a fair price for this small volume of second growth timber.
