#### REQUEST FOR STATE LEASE RENEWAL AND MODIFICATION OF LEASE BERMS

PERTINENT INFORMATION:

- 1. Under the terms of the subject lease, paragraph 18, the lessee has the right to renew this lease for successive periods of 10 years each upon such reasonable terms and conditions as the State may impose.
- 2. Royalty presently paid for all sand extracted from the lease is calculated as follows:

R = 0.03 + .10(C - 0.30)

Where

R = Royalty in dollars and cents per subic yard of sand extracted

C = Weight of sales price of sand per cubic yard.

Royalty under this schedule is basically 10% of the weighted average sales price but not less than \$0.10 per cubic yard.

- 3. As a condition of renewal, the following modification of terms in the subject lease are recommended.
  - (1) The basic royalty formula shall remain the same except that the last month of the lease year (October) will be used to determine the "C" factor; with such factor to

be adjustable by the Commission staff throughbout the term of the Lease. The effective date of this lease renewal is hereupon determined to be November 1, 1977. The "C" factor for October, 1977, has been determined to be \$2.86 and the royalty for the ensuing lease year therefore is \$0.286 per cubic yard.

A minimum extraction amount of 50,000 cubic yards of material per year shall be specified in Paragraph 10 of the lease.
