AREA, TYPE LAND AND LOCATION:

A 0.184 acre parcel of sovereign land in the bed of the Colorado River, Riverside County; located 12 miles wouthwest of Parker. Arizona.

LAND USE:

Right-of-Way for a bridge.

TERMS OF PROPOSED PERMIT:

Initial period: 49 years from December 15, 1977.

CONSIDERATION:

The public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES: Applicant is owner of upland.

Processing costs have been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:

- 1. The annual rental value of the site is estimated to be \$100.
- This project is exempt from CEQA because it is primarily a replacement of an existing older structure on the same

3. This project is situated on land identified as possessing environmental values in that the State Lands Commission has found that all waterways under the Commission's jurisdiction have environmental significance. Staff finds this project to be compatible with Commission policy.

A strip of land 40 feet wide, in the bed of the Colorado River, in Riverside County, California, said strip being adjacent to Sect on 34, TIS, R24E, SBM and Lying 20 feet on each side of the following described centerline:

BEGINNING at Station 137+00 on the centerline of the Agnes Wilson Road; thence S 89 58' E, along said centerline 600 feet to Station 143+00 and the end of the herein described centerline.

EXCEPTING THEREFROM any portion lying easterly of the "Interstate Compact Delining the Boundary Between the States of Arizona and California" as approved by House of Representatives Resolution 14578, dated August 11, 1966;

ALSO EXCEPTING THEREFROM any portion lying landward of the high water mark of the right or westerly bank of the Colorado River.
