- This transaction terminates an existing lease between Pacific Gas and Electric Company and the State Lands Commission, Loase PRC 2964.1, dated January 17, 1962, and replaces it with a new agreement which incorporates the Commission's current leasing policies.
- An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation,
 - This project is situated on State and identified as possessing significan: environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class C which authorizes Multiole Use.
