AUTHORIZATION TO RELEASE ASSIGNOR FROM ANY LIABILITY UNDER PRC 1395.1

RACKGROUND:

The Commission, at its meeting on November 24, 1977, authorized the amendment and assignment of PRC 1395.1, from Hollywood Turf Club (Assigner) to Hanna-Barbera Marineland (Assignee); a 0.501 acre parcel of tide and submerged land in the Pacific Ocean at Long Point, Palos Verdes Peninsula, Los Angeles County. The amended and assigned lease was for a period of 15 years beginning December 1, 1977, with one 10 year option to renew. Provision was also made for a surety bond and public liability insurance. Annual consideration is to be \$2,960, with the State reserving the right to set a different rental every 5 years.

CURRENT SITUATION:

Subsequent to the Commission's approval of this transaction, Commission's Staff was contacted by the parties involved expressing their desire that the assignor, Hollywood Turf Club, not be held liable under the terms of the assigned lease.

The Staff explained that the Commission would have to approve this situation. The assignee, Hanna-Barbera Marineland, is a partnership of National Corporations which includes Taft Broadcasting Company and the Kroger Company, both of which are listed on the New York Stock Exchange. Upon review of this situation, staff considers the assignee to be fully capable of meeting the terms of this lease, and recommends that the assignor be released from liability.
