AUTHORIZATION FOR SUIT FOR TRESPASS

PROSPECTIVE DEFENDANT:

Mr. Robert A. Sieglitz 1911 Garden Highway Sacramento, Galifornia

95823

AREA, TYPE LAND AND LOCATION:

Tide and submerged lands of the Sacramento River, Sacramento County, located adjacent to Assessor Parcel No. 274-021-06, known as 1911 Garden Highway, Sacramento.

BACKGROUND:

On February 23, 1976, the staff observed and photographed the Sieglitz vessel, a converted military vessel, moored on the subject land. On March 19, 1976 the staff wrote Mr. Sieglitz and informed him that his exclusive occupation of such sovereign land would require that he, Sieglitz, obtain a lease or permit for use of the same from the State Lands Commission. An application for the lease or permit was enclosed therewith.

In April, 1976, Mr. Sieglitz informed the staff that his position was that the land in question is not within the Commission's jurisdiction, because his vessel had been registered by the United States Coast Guard.

On June 1, 1976, the staff responded to the April letter, disputed Mr. Sieglitz's claim, reiterated the need for a permit or lease, and again enclosed an application. On September 15, 1976, the staff again informed Mr. Sieglitz of the necessity for a lease or permit.

CURRENT SITUATION:

On October 7, 1977, the staff again informed Mr. Sieglitz of the necessity of a lease or permit and enclosed application for the same therewith. On January 17, 1978, the staff again informed Mr. Sieglitz of the necessity, enclosed an application,

and stated that if, within 30 days of January 17, the staff did not receive a completed application, its only recourse would be to recommended that the Commission institute litigation to resolve the matter. On March 3, 1978 the staff attempted to inform Mr. Sieglitz by certified mail that such recommendation would be made. Mr. Sieglitz, however, refused to accept the staff's letter.

The staff has received no communication from Mr. Sieglitz subsequent to his letter of April, 1976.
