A. Statutory filing fees, permit fees and expense deposits have been submitted by the applicant.

B. Land has not been classified as known geothermal resources land.

## OTHER PERTINENT INFORMATION:

Getty 0il Company has submitted applications covering the proposed permit areas, and has notified the surface owners of the applications pursuant to Section 2252(d), Article 4.1, Division 3, Title 2 of the California Administrative Code. The surface owners, did not submit applications within the allowed 6-month time period, therefore Getty has acquired the right to the permits on the subject lands.

The applicant proposes to conduct exploratory work adjacent to or in the permit areas to determine if geothermal resources occur beneath State land. Such exploratory work may include geological, geochemical and geophysical work, as well as the drilling of exploratory well.

Cenozoic volcanic and intrusive rocks.
Parcel W 9369 is located in a Federally designated KGRA 2 mile south of a well that had a surface temperature of 96°C (205°F). The other parcels are located outside of the KGRA near wells that contain mineral waters. Since there are no commercial geothermal wells on or near the parcels; the parcels cannot be classified as being within a known geothermal resources area.

The proposed permit form has been approved by the Office of the Attorney General as to compliance with applicable provisions of the law and the rules and regulations of the Commission.

### ENVIRONMENTAL IMPACT:

Pursuant to Division 13 of the Public Resources Code, EIR No. 211, has been prepared and is on file in the Office of the State Lands Commission, available for public review. Upon discovery of geothermal resources, the preferential rights to convert the permits into geothermal leases will be subject to an additional EIR covering proposed commercial operations.
