AUTHORIZATION TO FILE DISCLAIMER ON  
CERTAIN PARCELS OF LAND IN COLUSA COUNTY

The State Lands Commission is a party to a condemnation action brought by the United States, filed in the United States District Court, Eastern District of California; involving parcels of land in Colusa County to be used in conjunction with the Colusa Tehama Canal of the Central Valley Project.

Upon examination of the Commission's records pertinent to the area, it was ascertained that there is no interest held by the State Lands Commission as to the tracts of land described in the notice of condemnation.

Inasmuch as this suit involves land over which the Commission has no jurisdiction, it is recommended that a disclaimer be filed on behalf of the State Lands Commission disclaiming any compensable right, title or interest in the tracts of the subject condemnation.
