### DREDGING PERMITS

In accordance with the Commission's delegation of authority to the Executive Officer for issuance of dredging permits of 10,000 cubic yards or less, permission was granted to perform maintenance dredging on State owned tide and submerged lands in the Napa River and granted lands, minerals reserved to the State, in San Diego Bay, to the following:

Street, Napa, California 64558: 500 cubic yards, spoils to be placed upon private upland property at a charge of \$0.25 per cubic yard; permit expires May 31, 1979.

San Drego Sea Port Village Limited, 3344 South La Clenega Boulevard, Los Angeles, California 600 cubic yards; spoils disposed of at private upland property shall be assessed a royalty of \$0.25 per cubic yards; permit expires May 31, 1979.

### LAND DESCRIPTION
