TERMINATION OF A 20-YEAR GENERAL PERMIT -PUBLIC AGENCY USE, PRC 2925.9 AND ISSUANCE OF 35-YEAR GENERAL PERMIT

APPLICANT:

City of San Clemente 100 Avenida Presidio

San Clemente, California 92672

AREA, TYPE LAND AND LOCATION:

Tide and submerged land westerly of the City of San Clemente, Orange County.

LAND USE:

The renovation, operation and maintenance

of an existing public fishing pier.

TERMS OF ORIGINAL PERMIT:

Initial period: 20 years from August 1,

TERMS OF PROPOSED PERMIT:

35 years from September 1, Initial period:

1978.

CONSIDERATION: The public use and benefit, with the State

reserving the right at any time to set a monetary rental if the Commission finds

such action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:

P.R.C. Code: Div. 6, Parts 1 & 2. Α.

Cal. Adm. Code: Title 2, Div. 3. Β.

OTHER PERTINENT INFORMATION:

- The annual rental value of the site is estimated to be \$5,000.
- 2. A negative declaration was prepared by the City of San Clemente, pursuant to CEQA and implementing regulations. A notice of determination has been received.

3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class C, which authorizes Multiple Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

- 4. The City of San Clemente and the California Department of Fish and Game, represented by the Wildlife Conservation Board are entering into an agreement whereby the State will share in the cost to renovate the pier. To do this the State is requiring the city to sublease the pier to the California Department of Fish and Game for a period of 25 years. The pier must be open to the public and the city will pay for maintenance.
- 5. Approval of this agreement by the Commission will terminate an existing permit for the pier and substitute the new permit. Also, approval of the new permit by the Commission will constitute approval of the 25-year sublease to the California Department of Fish and Game.
- 6. The city has 3 existing subleases on the leased premises. Commission approval of subleases was not a requirement of the existing permit PRC 2925.9.

 The city explains the revenue these subleases generate is substantially less than pier maintenance costs reported at approximately \$30,000 per annum. These subleases include:
 - a. Cafe
 Leased by M. F. Gable and D. Gable.
 The city receives 10% of their
 gross income or approximately \$7,500
 a year in rent.

- Bait Shop
 M. T. Baker
 J. M. Baker, lessee.
 The city receives 10% of thier
 gross income or approximately \$1,600
 a year.
- c. Telescope
 J. O. Carden, lessee.

- 7. This is an existing structure which is exempt from Article 6.5, of Title 2, of the Cal. Adm. Code.
- 8. The staff recommends waving the processing fee because of the public benefit of the project and the multipublic agency involvement in this transaction.

- 6. AUTHORIZE THE TERMINATION OF PERMIT PRC 2925.9 BEGINNING AUGUST 28, 1962.
- 7. AUTHORIZE ISSUANCE TO THE CITY OF SAN CLEMENTE OF A 35-YEAR GENERAL PERMIT PUBLIC AGENCY USE FROM SEPTEMBER 1, 1978; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE OPERATION AND MAINTENENCE OF A PUBLIC FISHING PIER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
- 8. AUTHORIZE THE SUBLEASE OF THE LEASED PREMISES TO THE CALIFORNIA DEPARTMENT OF FISH AND GAME FOR A PERIOD OF 25 YEARS BEGINNING SEPTEMBER 1, 1978, AND EXISTING SUBLEASES TO M. GABLE AND D. GABLE FOR A CAFE, TO M. BAKER AND J. BAKER FOR A BAIT SHOP AND TO J. CARDEN FOR A TELESCOPE.



NEGATIVE DECLARATION

Pursuant to Division-13 Public Resources Code

Description of Project - City Project

Renovation of existing San Clemente Municipal Ocean Fishing Pier.

The project will include replacement and repair of all wood decking superstructures, piling, and electrical system, including replacement of existing light fixtures.

All work will be done to restore existing pier. No modification other than electrical system and light fixtures will be made. The electrical system will be replaced with one that meets present code requirements.

Findings

This action is a periodic maintenance project. No significant fauna, flora, historical or archaeological items being disturbed. Public service facilities will be improved and the project will not be growth-inducing.

There will be no significant adverse impact on the environment.
