APPLICANT:

Larkspur Shores Association 635 South Eliseo Drive, Unit 1 Greenbrae, California 94904

AREA, TYPE LAND AND LOCATION:

Approximately 0.055 acre parcel (2,380 square feet) of tide and submerged land in Corte Madera Creek, City of Larkspur, Marin County.

LAND USE:

Proposed floating dock and gangway.

TERMS OF PROPOSED PERMIT;

Initial period: 10 years from March 1,

1978.

Public liability insurance: \$100,000 combined

single limit coverage for bodily injury and property damage.

CONSIDERATION:

\$50 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

BASIS OF CONSIDERATION:

\$50 fixed rental for this type of permit.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee and first year's rent have been received.
