Maintenance of a submarine cable crossing for transmission of 120 and 240-volt power

service.

TERMS OF ORIGINAL LEASE:

Initial period: 15 years from June 27,

Renewal options: 3 successive periods

15 years.

TERMS OF PROPOSED LEASE:

Initial period: 49 years from June 27,

1978.

CONSIDERATION: \$100 per annum, with the State reserving

the right to fix a different rental on each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

\$100 minimum rental for this type of lease.

Applicant is permittee of upland.

  - Generally to bring the lease format into current leasing policy.
- 2. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1(B), which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
- 3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.
