22. W 21806 Cook AUTHORIZE ACCEPTANCE, AS STATE SOVEREIGN LANDS, OF DEED PRC 5604 TO PARCEL ALONG PETALUMA CREEK, SONOMA COUNTY, ACQUIRED AS MITIGATION BY THE CALIFORNIA DEPARTMENT OF FISH AND GAME, AND AUTHORIZE TRANSFER OF CONTROL AND POSSESSION AND LEASE TO THE DEPARTMENT

The California Department of Fish and Game has obtained a deed to the State from Shellmaker, Inc., to a parcel of 2.98+ acres of real property in Sonoma County, more particularly described as the "Deed Parcel" in the attached Exhibit "A" (descriptions) and depicted on the attached Exhibit "B". The parcel was requested as mitigation by the Resources Agency on February 11, 1976 pursuant to Notice of Intent (SCH 75102779) which resulted in Final Environmental Statement, Shellmaker, Inc. application, United States Army Corps of Engineers, San Francisco District, January 1977.

The parcel was owned by Shellmaker, is located outboard of the Shellmaker Marina; and is immediately adjacent to and landward of the State's sovereign title to the bed of Petaluma Creek. The Shellmaker/State boundary and titles were permanently established by agreement (BLA 121) between the Commission and Shellmaker Inc., recorded in Book 2495, page 406 on November 9, 1970, in the Official Records, Sonoma County Recorder. The effect of the deed presented for acceptance is to add to the State's sovereign ownership the additional 2.98+ acres adjoining the State title to the bed of the PetaTuma River.

Upon Commission acceptance, the deed parcel will take on the character and protections attaching to real property owned by the State in its sovereign capacity subject to the public trust. As the parcel is acquired by the State solely as a result of the efforts of the Department of Fish and Game they seek a transfer by the Commission of control and possession pursuant to Government Code Section No. 14673 for so long as it is used for wildlife preservation purposes.

Minerals are to be reserved without the right of surface entry. They also request a lease of an additional 20 acres, more or less, extending into the Petaluma River to its center line for efficiency in management. The lease parcel

to the center line is called "The Petaluma River Parcel" and is described in the attached Exhibit "A" and is depicted on the attached Exhibit "B".

- 4. AUTHORIZE THE STAFF OF THE STATE LANDS COMMISSION AND/OR THE OFFICE OF THE ATTORNEY GENERAL TO TAKE ALL FURTHER STEPS WHICH MAY BE REASONABLY NECESSARY AND CONVENIENT TO IMPLEMENT THE TRANSACTION DESCRIBED ABOVE, INCLUDING BUT NOT LIMITED TO EXECUTION OF DOCUMENTS OF TITLE, RECORDATION, ESCROW INSTRUCTIONS AND APPEARANCES IN ANY LEGAL PROCEEDINGS BROUGHT CONCERNING THE ABOVE TRANSACTION.


