TERMS OF ORIGINAL LEASE:  
Initial period: 10 years from October 24,  
1977.

Public liability insurance: Combined single  
limit coverage of \$100,000.

Consideration: \$396.83 with the State  
reserving the right to  
fix a different rental  
on each fifth anniversary  
of the lease.

\$300 processing fee has been received.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is on existing land use for which no adverse comments have been made.

3. The rental rate is \$1.51 per Animal Unit Month and the carrying capacity was estimated at 262.8 AUM's,  $\$1.51 \times 262.8 = \$396.83$  annual rental.

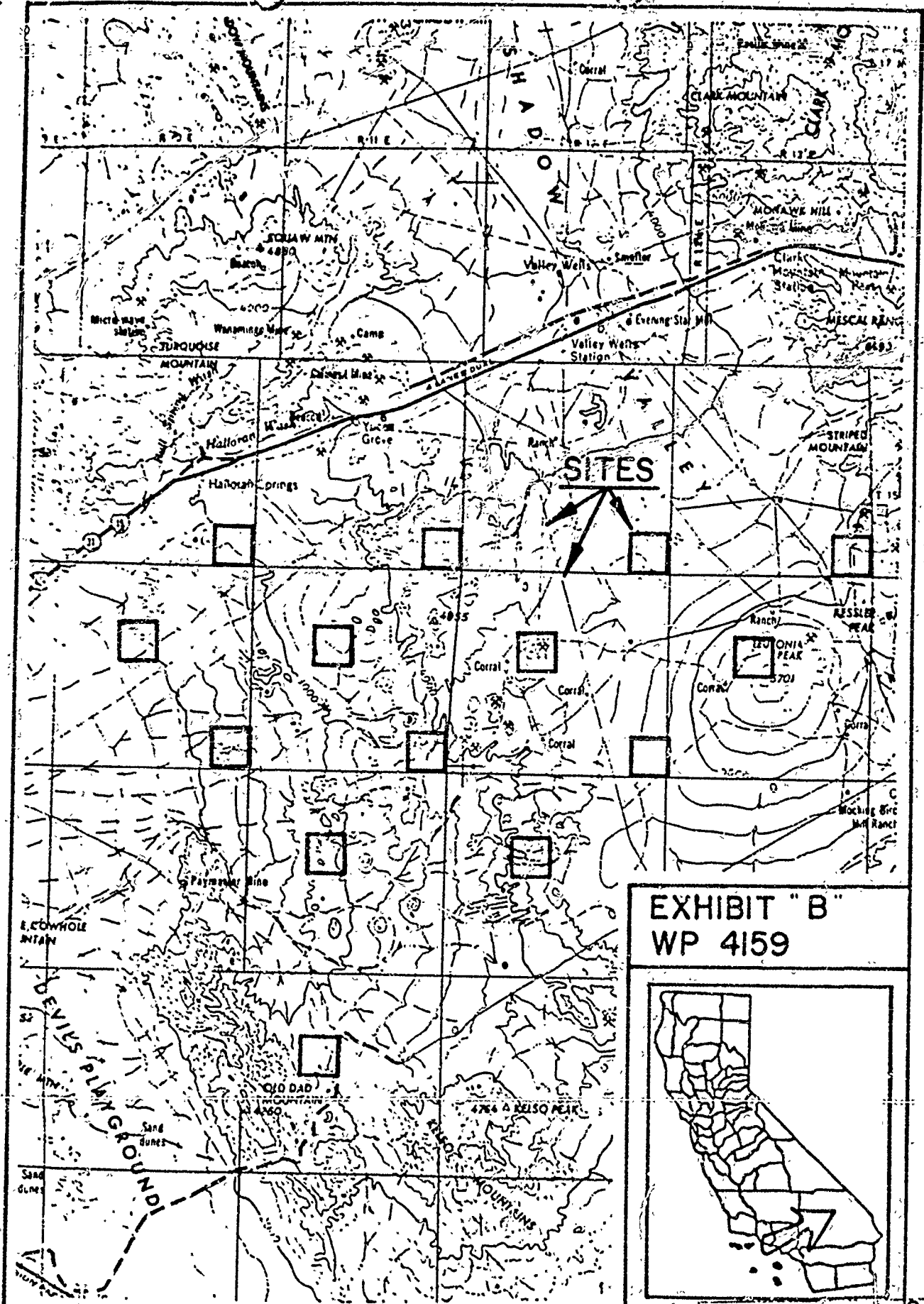
