AUTHORIZATION TO FILE DISCLAIMERS

The State Lands Commission is a party to certain condemnation actions brought by the United States, filed in the United States District Court, Eastern District of California; involving 8 parcels of land in Colusa and Yolo Counties to be used in conjunction with constructing the Colusa Tehama Canal of the Central Valley Project. Those federal condemnation actions include federal civil Nos: S78-680-TJM for 12.9 acres; S79-54-PCW for 6.1 acres; S-79-55-TJM for 13.6 acres; S-79-56-PCW for 38.2 acres; S-79-57-TJM for 6.4 acres; S-79-58-PCW for 10.4 acres; S-79-26-PCW for 3.4 acres; and S-79-81-TJM for 31.7 acres.

Upon examination of the Commission's records pertinent to the area, it has been ascertained that there is no interest held by the State Lands Commission as to the parcels of land described in the above mentioned condemnation actions.

Inasmuch as these suits involve land over which the Commission has no jurisdiction, it is recommended that disclaimers be filed on behalf of the State Lands Commission disclaiming any compensable right, title, or interest in the parcels covered by the above mentioned condemnation actions.

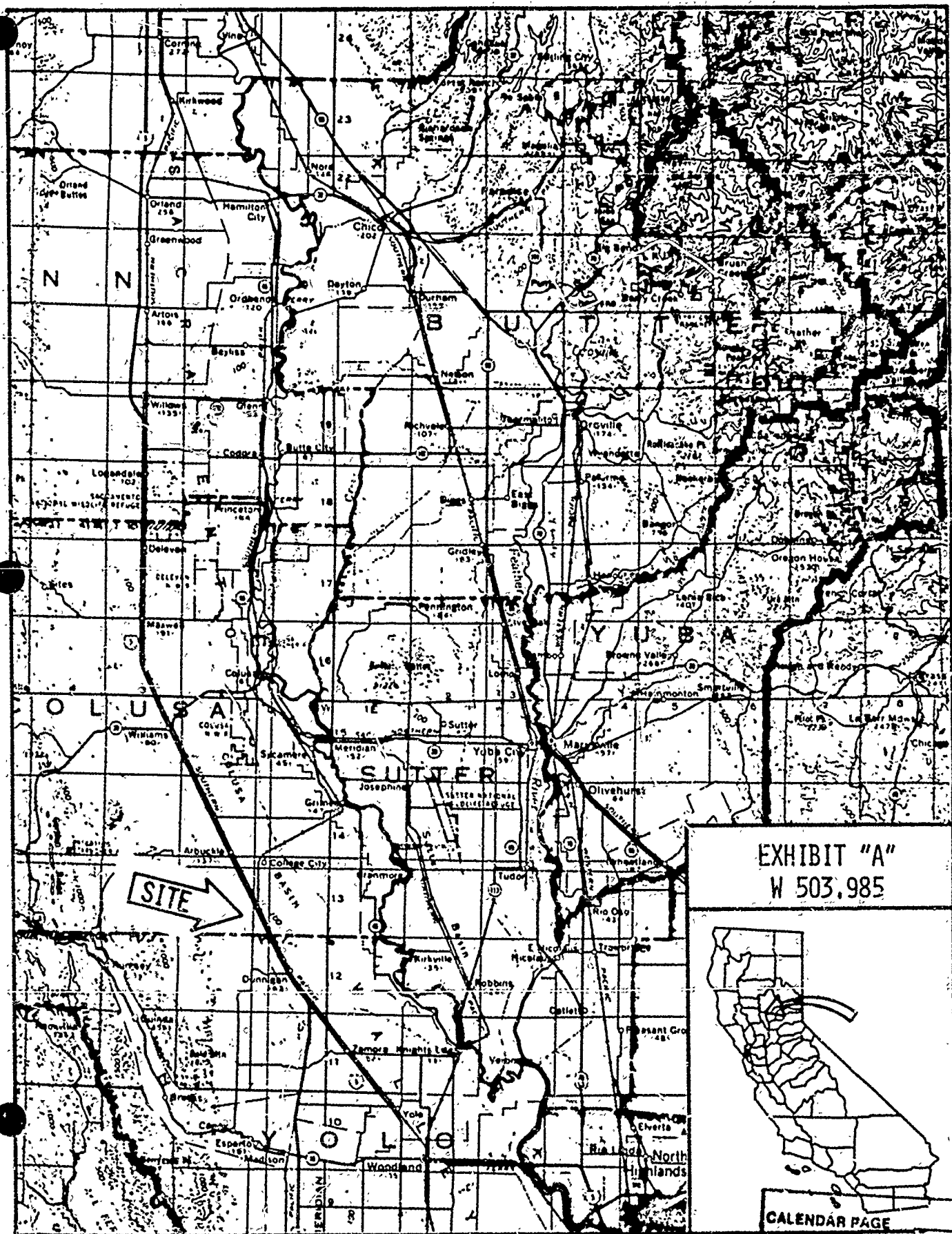

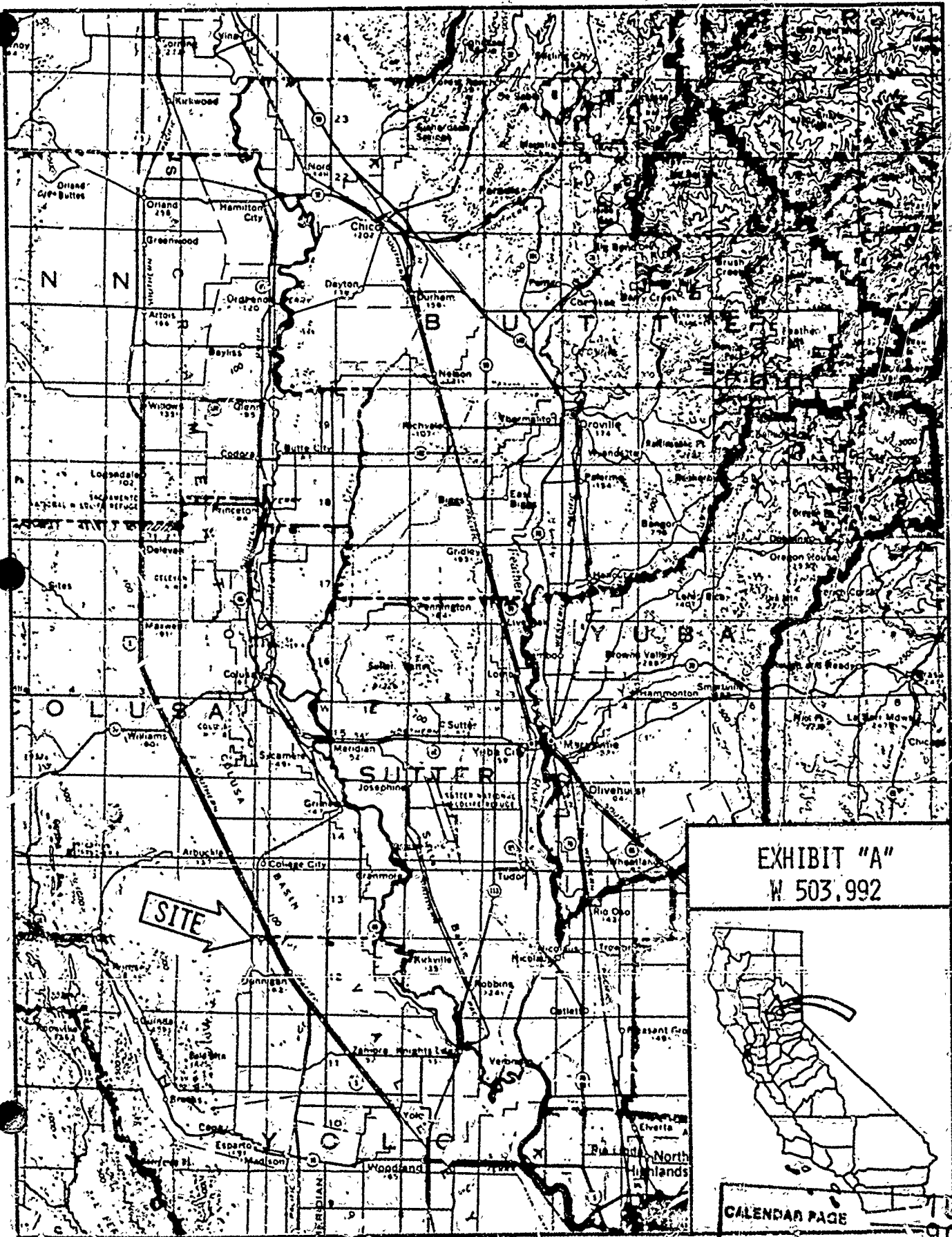

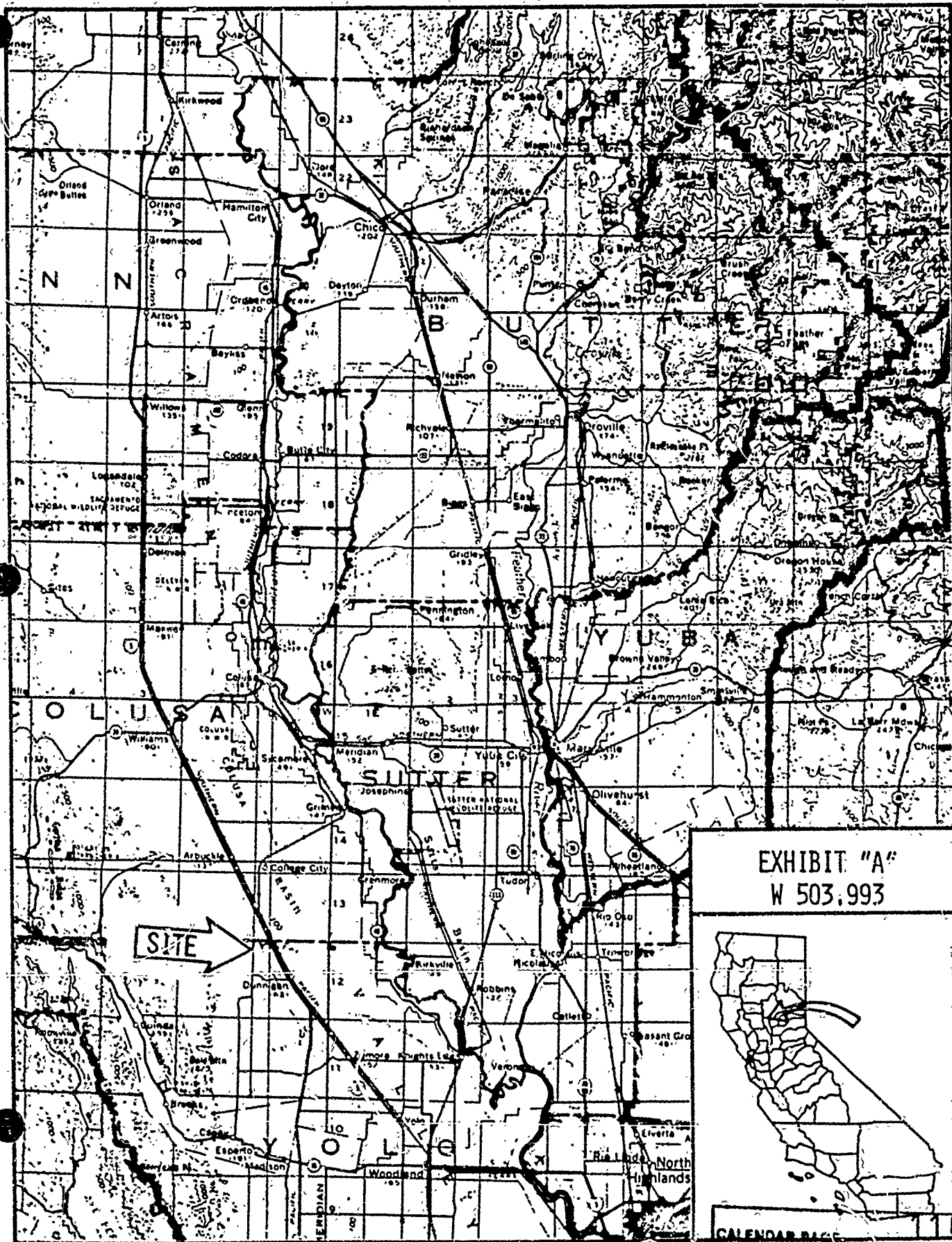

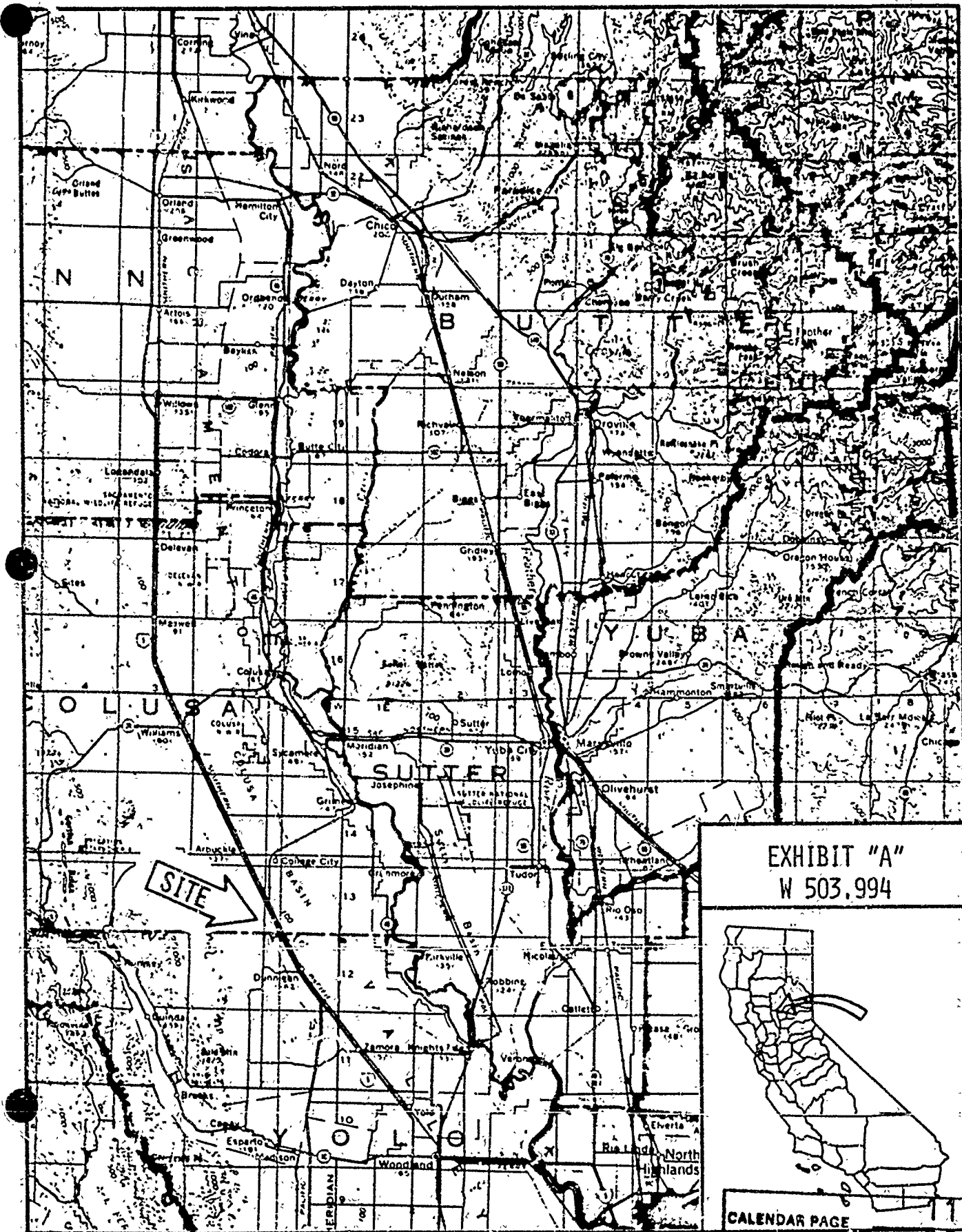

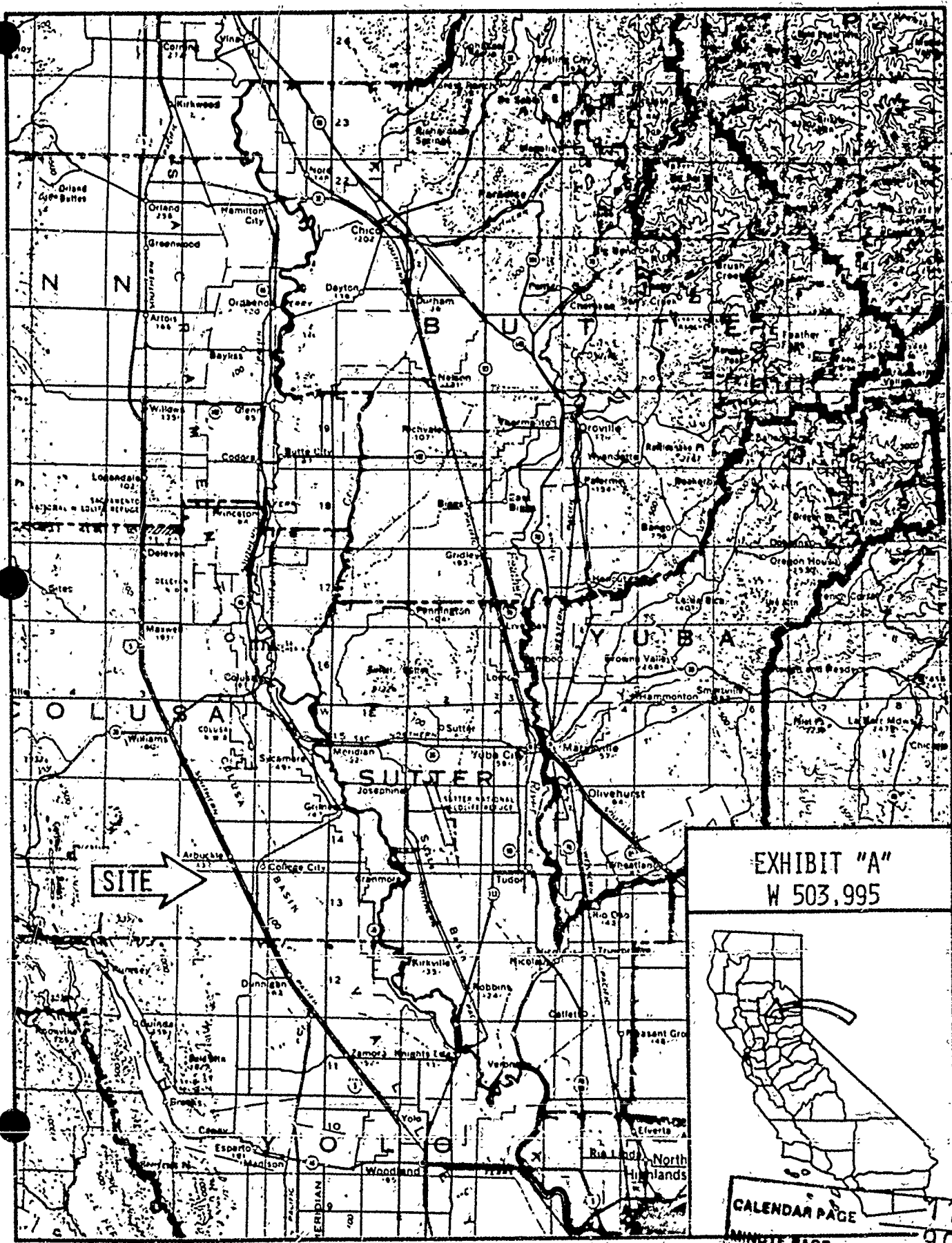

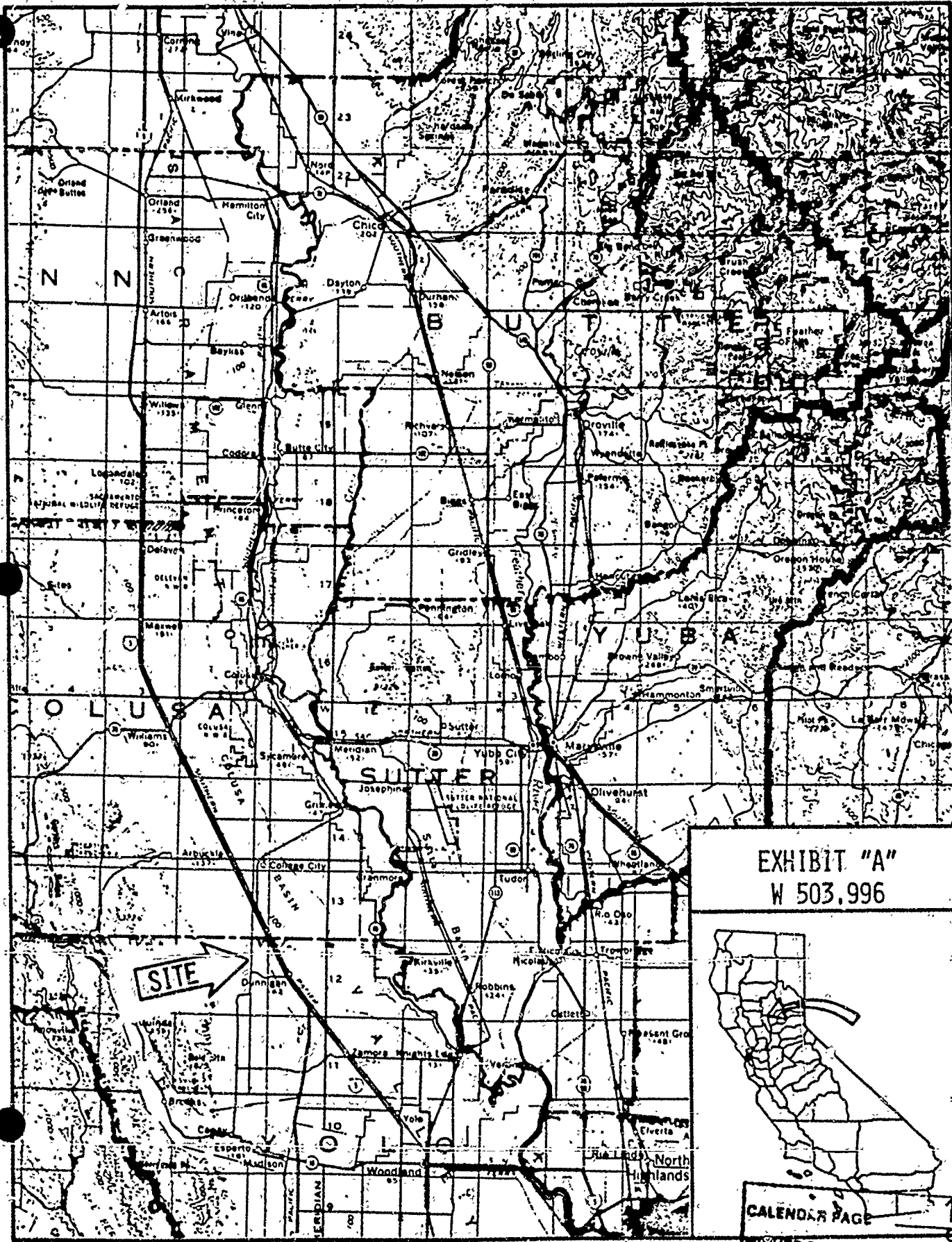

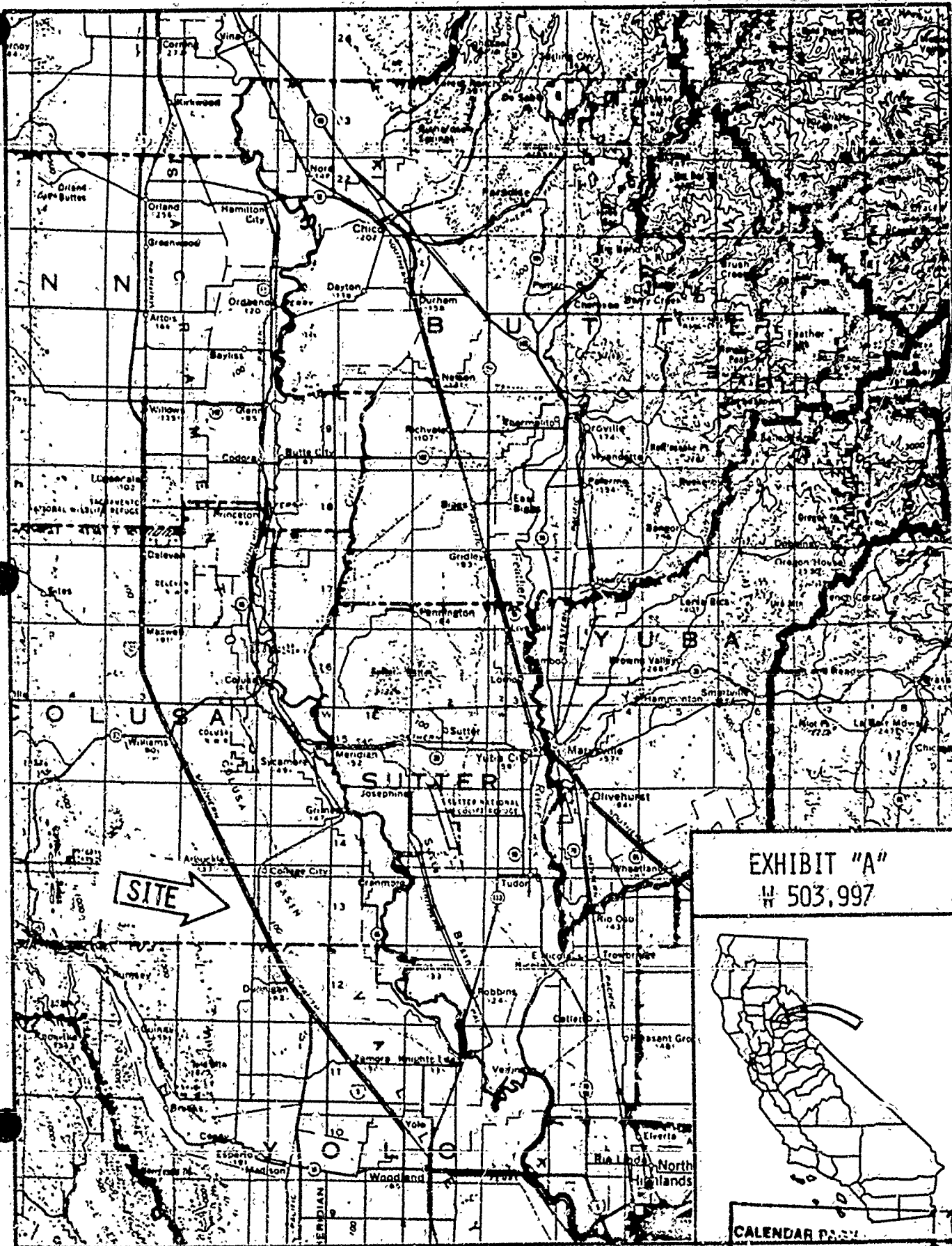

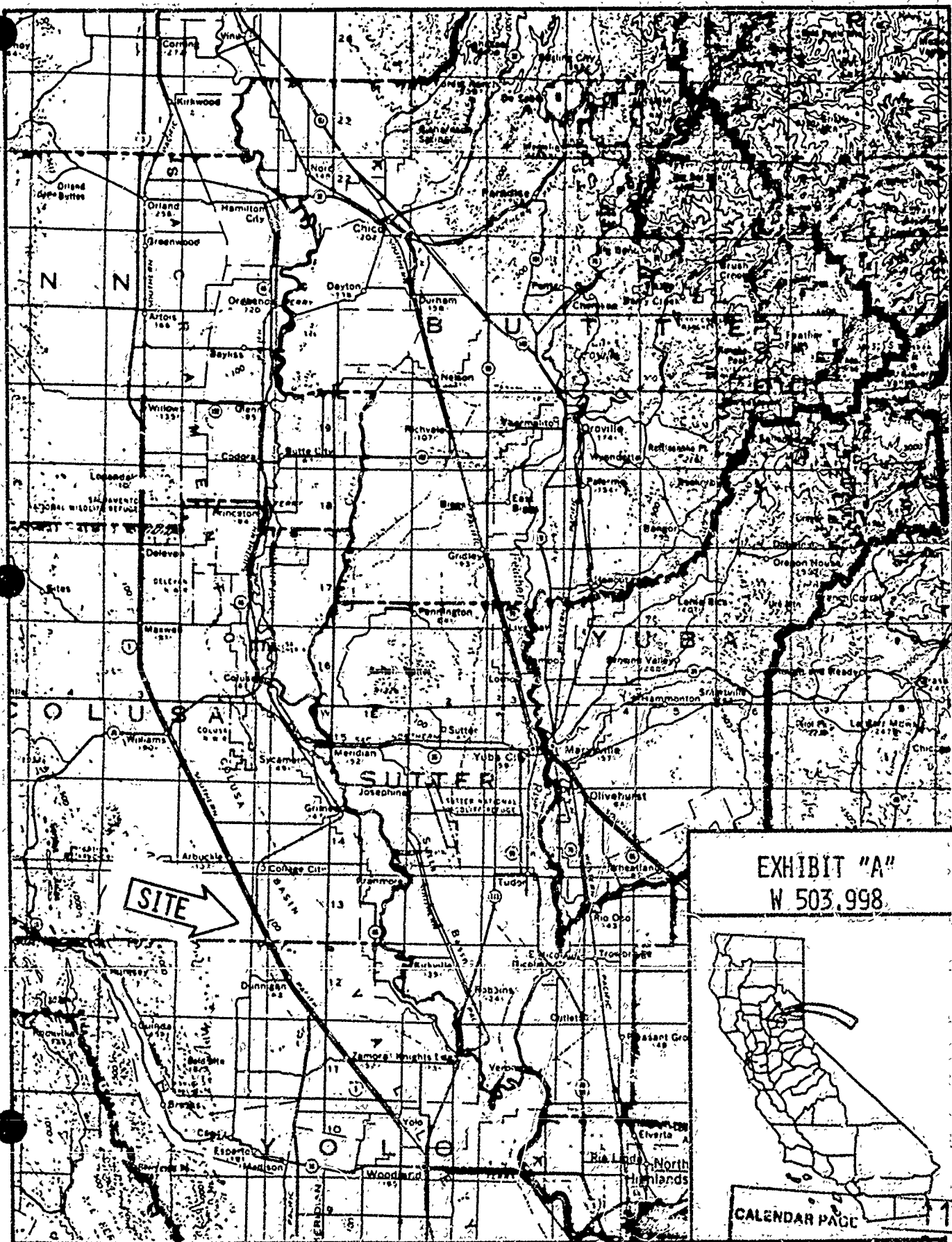
