APPROVE PROPOSED ADDITIONAL COST
SUBSIDENCE STUDIES, STATE LANDS EXPENSE
CITY OF LONG BEACH

SUBSIDENCE REMEDIAL PROJECT:

Subsidence Studies, State Lands Expense,
1978-79 fiscal year.

SUBSIDENCE ELEMENTS:

- (a) City's Presentation: Additional funds of \$15,000 are needed to cover staff work on subsidence cost reimbursable projects in the current fiscal year.
- (b) Staff Analysis: Additional subsidence costs may be appropriate.

COST OF THE PROJECT:

- (a) City's Estimate: \$15,000.
- (b) Staff Analysis: \$15,000 recommended.

FISCAL IMPACT: Approved costs will be borne 100% by the State.

STATUTORY AUTHORITY:

- (a) City's Reference: Chapter 138/64, 1st. E.S.
- (b) Staff Determination: Chapter 138/64, 1st E.S., Sec. 1(e).

DISCUSSION:

On June 28, 1978 the Commission gave the City prior approval to expend \$80,000 for State Lands Expense during the 1978/79 fiscal year. On April 2, 1979 the City requested prior approval of an additional \$45,000 for the remainder of the fiscal year because of heavier than normal workload in negotiating settlement of completed subsidence projects. The staff questioned the need for this amount of fund augmentation. On April 16, 1979 the City revised its requested amount down to \$15,000. The City estimates that the current prior approved amount of \$80,000 will be expended by the end of May, 1979.
